In producing herewith following three arrested persons namely MD Iman (25 years) S/O Lt MD Sarifuddin of Limbu busty near Masjid, ward no 42, PS Bhaktniagar, Jalpaiguri. 2) Ismile Alam @ Nazim (23 years) S/O Md Fajur Uddin of Amal Jhari, PS Islampur, Dist Uttar Dinajpur A/P Limbu busty near Masjid, ward no 42, PS Bhaktniagar, Jalpaiguri. 3) Rohit Darjee (22 years) S/O Lt Bimal Darjee of Namthang Radha Pani, PS Namchi, Dist South Sikkim, A/P Milan more near osain Cafe, PS Pradhan Nagar Dist Darjeeling along with following seized articles viz:

One iron made knife with wooden butt measuring approx 12 inches recovered from the exclusive and Conscious possession of Md Iman.

2) 27 One iron made hammer measuring approx 10 inches recovered from the

exclusive and Conscious possession of Ismile Alam @ Nazim

One iron Plier measuring approx 06 inch recovered from the exclusive and Conscious possession of Rohit Darjee.

I, SI Youel lepcha S/O Jai Tshering Lepcha of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted persons and 8/9 others to the effect that on 19.08.2025 at 00:10 hrs received a specific source information that 11/12 miscreants have assembled at PC Mittal Bus Terminus under Bhaktinagar PS, with deadly weapons and making preparation for committing dacoity to the passerby area. Accordingly I informed the matter to the I/C, Bhaktinagar PS and diarized the fact in General diary vide Bhaktinagar PS GDE No.888 dated 19.08.25 and as per order I along with SI Srimanta Chatterjee, ASI Khagen Barman, ASI Dhurba Mishra and C/374 Debraj Biswas all of Bhaktinagar PS, SPC, left for PC Mittal Bus Terminus under Bhaktinagar PS to work out the information in hand vide GDE No-889 dated 19.08.2025.

At about 00.25 hrs we arrived at the PC Mittal Bus Terminus as indicated by the source we noticed that 11/12 persons assembled there and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started shouting police and started to flee away from the spot but we the police party after somehow managed to apprehended above noted 03 (three) of them with deadly weapons in their possession but 8/9 persons managed to fled away from the spot taking the advantage of darkness and open place. On being asked the apprehended accused persons disclosed their name and identity as noted above. During interrogation they stated that they were present there and making preparation for committing dacoity to the passerby area. On search the above noted weapon of offence recovered from their exclusive and conscious possession.

On further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night.

Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest also informed them about ground of arrest in writing and observing all the formalities of arrest the whole search seizure was made on 19.08.2025 in between 00.55hrs to 01.20hrs the whole seizure was conducted under proper audio video record.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the arrested persons viz. Md Iman (25 years) S/O Lt MD Sarifuddin of Limbu busty near Masjid, ward no 42, PS Bhaktniagar, Jalpaiguri. 2) Ismile Alam @ Nazim (23 years) S/O Md Fajur Uddin of Amal Jhari, PS Islampur, Dist Uttar Dinajpur A/P Limbu busty near Masjid, ward no 42, PS Bhaktniagar, Jalpaiguri. 3) Rohit Darjee (22 years) S/O Lt Bimal Darjee of Namthang Radha Pani, PS Namchi, Dist South Sikkim, A/P Milan more near osain Cafe, PS Pradhan Nagar Dist Darjeeling others also arrange for its investigation.
