Subj- F.I.R. against Mr. Vikash Agarwal and his relative.

This is to inform that on 12/08/25 around 19:30 hrs Mr. Vikash Agarwal s/o Ramgopal Agarwal of Microtek Computers, 36/1 Seroke Road, Siliguri along with his one relative wearing black t-shirt in the video, both attempted to murder me with a stick taken out from his car WB74AX7540, Maruti desine blue colour.

They started abusing me with offensive words and slangs and then damaged my car WB74BN13299 from all sides, completely.

Presently my office has been situated beside his shop in Seroke Road in the name of M/s G2D Traders where I carry out the business of government supplies and contracts.

As near the office there has been no space to park car so upon basic practical concept it is known that one should park their own car in front of their own shop, but here Vikash Agarwal has been parking his own car in front of my office since a while which in turn becomes problematic for me to park my own vehicle. I would like to state here too since the parking of his car in front of my office is just to intentionally create nuisance and harassment and to show off his knowledge and power just because he has studied law, so in order to lower down and posing a threat to my ability he creates such nuisance and harassment and often gives threats to murder me if I do not obey his words.

It is also pertinent to mention here that after the occurrence of the above event that took place on 12/8/25 it has created a lot of trouble and fear within me and that I cannot even go to work properly thus causing a delay in lodging complain.

Unfortunately even after doing so much of nuisance, chaos, and harassment he is still parking his car daily in front of my office.

Therefore instead of creating any further problem and to avoid him and his relative I choose to lodge an F.I.R. against both culprits in order to protect myself from any threats of death and loss of property.

My car has been sent to the workshop Impression Honda on 16/8/25 for repairs whose approx estimate is around more than one lakh rupees.

There has been a CCTV camera situated outside the shop 'Microtek Computers' that belong to Vikash Agarwal and is believed to record the whole event of occurrence that took place.
