**SUBJECT: COMPLAINT AGAINST MY SON-IN-LAW, ARGHYA DAS, FOR
SUBJECTING ME TO MENTAL AND PHYSICAL CRUELTY, CRIMINAL
INTIMIDATION, MOLESTATION AND HARASSMENT.**

Sir/Madam,

I, Smt. Amita Dutta, W/o Sri Bankim Chandra Dutta, residing at village - Bhita, P.O. - Bhita, P.S. - DewanDighi Thana, District - Bardhaman, PIN - and currently residing at Nilgiri Apartment, Flat No- 3/A, Meghnad Sarani, Behind Vivekananda School, Hakim Para, P.O. & P.S. - Siliguri, District - Darjeeling, PIN - 713102, wish to lodge this complaint against my son-in-law, Arghya Das who is married to my daughter Smt. Pratiksha Dutta since the year 2020. My son-in-law Arghya Das is having an affair with a girl named Amisha Dutta in Siliguri and he has confessed the same to my daughter. And has been pressuring my daughter for divorce. On hearing these, I came to temporarily reside with my daughter at her place of residence to protect her against any sort of violence or harm.

Arghya Das is now regularly going out with his girlfriend Amisha Dutta on vacations and on 06.08.2025, he packed his luggage and informed me and my daughter that he was leaving for a vacation with his girlfriend. Before leaving, he explicitly threatened me again, stating that upon his return, he will throw both me and my daughter out of the flat.

Tonight all of a sudden my son-in-law returned home and started shouting and assaulting me. He took the induction where I was cooking, then proceeded within minutes to break the fridge and didn't stop at my daughter's request. He kept repeating that I should get out of the house but I suffered an injury recently with a major crack in my leg and also fearing for the safety of my daughter, I couldn't leave. He cut off the line of the inverter and further pushed me against the wall and got so enraged that he even tried to outrage my modesty by disrobing my apparel and as a result my broken leg also got hurt causing me severe pain and trauma.

Arghya Das then in front of me caught my daughter by her collar and kept slapping her and asking her to leave the house and also take me with her.
