He cut off the line of the inverter and further pushed me against the wall and got so enraged that he even tried to outrage my modesty by disrobing my apparel and as a result my broken leg also got hurt causing me severe pain and trauma.

Arghya Das then in front of me caught my daughter by her collar and kept slapping her and asking her to leave the house and also take me with her.
