I, SI Bikash Kisku (52 yrs), S/O Lt. Gopal Kisku, of the Cyber Crime PS, Siliguri Police Commissionerate, hereby lodge a written complaint stating that today, on 07.08.2025, at approximately 23:05 hrs, while I was engaged in social media monitoring at Cyber Crime PS, Siliguri, I found different communal provocative post by a digital creator named as 'Suraj Darnal' on social media platforms (Facebook). When I checked his personal Facebook ID namely 'Suraj Darnal Gorkha' I also found same kind of provocative posts and videos in his Facebook ID. The links are as follows https://www.facebook.com/suraj.darnal.9678 & https://www.facebook.com/suraj.darnal.9678 & https://www.facebook.com/suraj.darnal.9678

It is to be noted here that on 04.08.2025 one Ronita Lama resided at house of Pankaj Thakur of Hakim Para where Leena Dutta and Rubi Dutta also resided, lodged a complaint before Siliguri PS that they abused them with filthy language and uses derogatory words regarding her caste in public. In this matter a specific case had been lodged in Siliguri PS. Following this incident the alleged person having Facebook ID namely 'Suraj Darnal Gorkha' continually posted communal sensitive videos on his Facebook profile to provoke enmity between two communities. It was found from his Facebook ID that in the past, he had circulated this kind of video many a times.

In relation to this incident, many hateful comments are circulating on social media, spreading enmity between two communities with criminal conspiracy. This content is prejudicial to the maintenance of harmony and poses a severe threat to communal cohesion. It has the potential to provoke violence and unrest among communities within the local jurisdiction.

Hence, I pray that you kindly register an FIR against the user of the social media profile under proper section of law and take necessary action to remove the offending material from the respective social media platform, and conduct an investigation into this matter.
