In producing herewith Seven (07) accused persons named 1. Amit Das (19 yrs.), S/o - Lt. Madan Das of Madani Bazar, PO - Baribhasha, PS- NJP, Dist. - Jalpaiguri, 2. Chhatu Sikder @ Guru Chand (24 yrs.), S/o - Lt. Santosh Sikder of Madani Bazar, PO - Baribhasha, PS- NJP; Dist. - Jalpaiguri, 3. Srikantha Roy (19 yrs.), S/o - Lt. Sailen Roy of Madani Bazar, PO - Baribhasha, PS- NJP, Dist. - Jalpaiguri, 4. Susanta Roy (23 yrs.), S/o - Ganesh Roy of Madani Bazar, PO - Baribhasha, PS- NJP, Dist. - Jalpaiguri, 5. 2. One (01) Base Ball Bat length approx. 30" inch.
3. One (01) Axe along with bamboo Butt length approx. 24" Inch.
4. One (01) Iron made sword length approx. 30" inch along with wooden butt.
5. One (01) Iron made Crowbar length approx. 36" inch.
6. One (01) Electric Touch light.
7. One (01) Blue colour nylon rope length 30 feet's.

I ASI Nilam Swarnakar of New Jalpaiguri PS, SPC do hereby lodge a written complaint against the above noted accused persons and others 05/06 persons to the effect that on the night 18.08.25 at 00.15 hrs. received secret source of information to the effect that some miscreants armed with deadly weapons assembled in a dark place at South Colony Quarter Ground near Kendriya Vidyalay under NJP PS with a view to commit dacoit. Accordingly without waste any time I informed the matter to you and duty officer of PS and noted in NJP PS GDE No. 889 dated. 18.08.25. As per your kind direction at 00.20 hrs myself along with C/1462 Sajan Tamang, VP-13 Jamirul Islam VP 08 Laxman Roy left from PS vide NJP PS GDE No. 890 dated. 18.08.25 for South Colony Quarter Ground near Kendriya Vidyalay to verify the veracity of the information and to work upon it. We reached near the spot as confirmed by the source at about 00.35 hrs. and stopped our vehicle at a considerable distance from that place and we started walking towards the mentioned place. When we reached at South Colony Quarter Ground near Kendriya Vidyalay and found a group of 13/14 persons assembled and gossiping in a dark place as stated by the source. We started approaching them slowly ambushing ourselves in the darkness. But unfortunately one of them see the police and try to flee away from the spot. Somehow, after a hot chase we could able to apprehend the above noted Seven (07) persons and the others 05/06 persons managed to flee away from the spot taking the advantage of darkness. On interrogation they disclosed their identity which was not verified and they also stated that they along with their other associates assembled there with a view to commit dacoit after making full preparation in the nearby place of South Colony Quarter Ground near Kendriya Vidyalay under NJP PS. I try to manage the independent witnesses but due to late night I couldn't find any independent witness to be present at the time of search and seizure. Thereafter all the apprehended persons were searched and I found and recovered the above noted articles from their possession and seized the same under proper seizure list duly signed by them and the process of search and seizure has been recorded in audio-video means as per the provision of law. The seizure was made on 18.08.2025 in between 01.05 hrs to 01.35 hrs. Accordingly I arrested the above noted accused persons u/s 35 BNSS under proper memo of arrest and ground of arrest is duly communicated with them.
