P.O. Siliguri, P.S. Siliguri Police Panitanki
out post, Dist. Darjeeling, do hereby lodge
this FIR against one person, S. Senthil
Kumar, who is running also scrap motor
parts business adjacent to my shop
(address as stated above).

I have been carrying on my
motor parts business at the above mentioned
address for the past 10 years with good
will and peaceful conduct. However,
very recently said accused namely
S. Senthil Kumar, who open a shop next to
mine, has been causing constant harassm-
ent and breach of tranquility and peace.
He frequently uses abusive and filthy

languages specially under the influence of alcohol, and throws broken glass and other waste materials into my shop causing danger and obstruction to my business and life.

Sir, I am an old aged person and suffering from various health issues and despite repeated requests to maintain peace, said Accused continues to harass me and my entire family members.

On 19-08-2025 i.e. today at about 2.15 p.m (afternoon) while I was at my shop, at that time said Accused person came in an intoxicated condition, started threatening me using abusive words, filthy languages and suddenly committed physical assault upon me by Iron rod.

Moreover, he kicked me, causing me to fall on the ground. On hearing my screams, my son, Sri Rohit Singh came to rescue me, but the Accused then assaulted him as well using a screwdriver two times in several parts in his body and threatened that (तुम्हारे पैसे तोड़ दूँगा - I will destroy your money).

I am terrified and unable, The said Accused has shown no regard for law and order and is a constant threat to our lives and liberty.

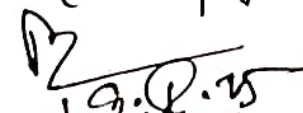

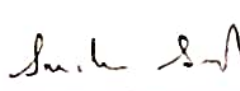
