I, Smt. Parbati Tigga, Wife of Late Manoj Tigga, resident of Bidhan Pally, P.O. Kadamtala, P.S. Matigara, Dist. Darjeeling beg to report you that on 14.08.2025 at about 1.0 P.M. when I with intend to visit my vest land measuring 10.0 Katha, situated within L.R. Plot No. 352 of Mouza - Abhiram, J.L. No. 567 under P.S. Bagdogra, Dist. Darjeeling I found that of (1) Sri Binay Ghosh, Son of Late Bijay Ghosh, resident of Ashok Nagar, Buri Balasan, Bagdogra and (2) Sri Arun Sharma, Son of Sri Ramdev Sharma, resident of Stalin Nagar, Upper Bagdogra, P.O. & P.S. Bagdogra along with their anti social gang were removing my bamboo boundary of my aforesaid land. For the work of removing my bamboo wall they had brought one JCB. I instantly raised my strong objection and asked them as to why they were removing my bamboo boundary and on my such objection both Sri Binay Ghosh and Sri Aran Sharma came near to me and started to abuse me throwing slang and filthy languages. But I did not keep up to raise my objection and stood in front of JCB as because the JCB was continuing its work for destroying my bamboo boundary wall. On my such deadly effort for saving my own land which I had purchased at my hard earned money, both Sri Binay Ghosh and Sri Arun Sharma held my arms in both side and dragged me out of the land and shouted at me saying that 'ei ta amader khatian Jomi. Chup kore chole ja ei khan theke.na hole tor muskit aache." But in spite of such obstruction I had not kept quite. I again tried to stop the JCB and this time both Sri Binay Ghosh and Sri Arun Sharma came to me again and held my arm and as well as my private parts and shouted again to me saying that "Tui sala aadivesi kalo meye. Tui ei bhabe manbi na.Toke rape kore mere phelbo. Tui amader Janis na. Thereafter, I was physically tired and my body was not permitting to struggle with them any more. Alas, I was left no alternate except to weeping and seeing my own land was grabbing by land mafia.

Due to physical conflict with said Sri Binay Ghosh and Sri Arun Sharma I was feeling ill. My mind was not properly working as I had wept for a long. I somehow came to my home and was planning to file F.I.R. against them on the next day. But I could not get up: from the bed on the very next day i.e., on 15.08.2025. and also on 16.08.2025my body was not permitting me to move. But meanwhile I came to know that said Sri Binay Ghosh and Sri Arun Sharma in order to get safeguard from the Police have filed a complaint case against me in your station.

That sir, I somehow managed to purchase my aforesaid land at my hard earned money which said Sri Binay Ghosh and Sri Arun Sharma have grabbed from my custody. I came to know that said said Sri Binay Ghosh and Sri Arun Sharma are very dangerous land mafia who had threatened me to rape and kill. I on the other hand am a widow belonging from tribal community and if they are not restrained they will grab my land which is my only property.

I therefore, humbly request you to kindly lodge the matter as state above as a counter F.I.R. in your P.S. and treat the matter as the case of Scheduled Caste and Scheduled Tribe (Prevention of Atrocities) Act, 1989 so that I may get back my land from the hands of land mafia
