- 1. That I had deposited a security amount with Sri Ram Finance Ltd., where Mr. Arjun Prasad and Mr. Rohit Roy are employees.
- 2. That since the last two days, I have been calling both of them repeatedly requesting the refund of my security money, but every time they gave lame excuses and avoided the matter.
- 3. That on 11-08-2025 at around 6:30 PM, I personally went to the office of Sri Ram Finance Ltd. to settle the matter. They told me to wait outside the office near a nearby petrol pump Gyan Jyoti More, Dagapur, PS Pradhan Nagar Dist Darjeeling and said they would come there to resolve the issue.
