Subject: Lodging of FIR against Mr. Arjun Prasad and Mr. Rohit Roy (employees of Sri Ram Finance Ltd.) for assault, criminal intimidation, and cheating.

Respected Sir,

I, Md Faiyaz Ansari, son of Md Fida Hussain Ansari, resident of Maszid Road Ashraf Nagar PO Haidarpara, Ward No. 40, Siliguri, Dist Jalpaiguri, Pin – 734006, West Bengal beg to lodge the following complaint for your kind action:

1. That I had deposited a security amount with Sri Ram Finance Ltd., where Mr. Arjun Prasad and Mr. Rohit Roy are employees.
2. That since the last two days, I have been calling both of them repeatedly requesting the refund of my security money, but every time they gave lame excuses and avoided the matter.
3. That on 11-08-2025 at around 6:30 PM, I personally went to the office of Sri Ram Finance Ltd. to settle the matter. They told me to wait outside the office near a nearby petrol pump Gyan Jyoti More, Dagapur, PS Pradhan Nagar Dist Darjeeling and said they would come there to resolve the issue.
4. That when they came, instead of resolving the matter, they started abusing me in filthy language and physically assaulted me with fists, blows, and kicks and they further snatched away my gold chain and cash rupees 2500 from my pocket.
5. That they further told me that the security money had already been withdrawn and utilized by them, and they would not refund anything.
6. That they also threatened me by saying that if I try to lodge any complaint against them, they would kill me.

I, therefore, request you to kindly register my complaint as an FIR, investigate the matter, and take necessary legal action.
