Sir,

With due respect, I am producing herewith one accused person namely Rajan Lohar (M-32) yrs S/o Late Man Bahadur Lohar of Dhap Goan, P.S. Shukhia Pokhiri, Dist. Darjeeling under arrest and the following seized articles viz :- (i) One paper made cartoon containing 12 (twelve) bottles of "TUBORG premium beer each bottle containing 650 ml i.e. total (12 x 650 ml = 7.800 ltrs) - Marked as Exhibit "A" out of which one bottle of the same taken as sample for examination and Marked as exhibit "A1".

I ASI Prabal Sarkar of Pradhan Nagar PS, SPC do hereby lodged this written complaint against the above noted arrested accused person namely Rajan Lohar (M-32) yrs S/o Late Man Bahadur Lohar of Dhap Goan, P.S. Shukhia Pokhiri, Dist. Darjeeling to the effect that on 12.08.2025 at 14.15 hrs. I received source information that one person would be come to Hill Cart Road near Gurung Busty More with huge quantity of illicit liquor with a view to sale the same to his design customers at Siliguri Junction. Accordingly, I diarized the fact in PS General Diary vide Pradhan Nagar PS GDE No. 755 dated 12.08.2025 and informed the matter to you. As per your kind order and direction, I along with SI Bandhan Roy, ASI Biplab Kr Das and force all of Pradhan Nagar PS left for Gurung Busty More by Govt vehicle with investigation kit to verify the veracity of the information. At around 14.55 hrs we arrived at Gurung Busty More and contact with my source and at around 15.00 hrs being identified and shown by the source I noticed that one person was coming from SNT More side and proceeding towards Gurung Busty More. I managed to stop the person at Gurung Busty More near R.K. Music and managed to detain him. On interrogation he disclosed his identity as noted above. On search him we recovered the above noted articles from his possession. On demand he failed to produce any documents in respect liquor recovered from his possession. During local enquiry it could be revealed that the person namely Rajan Lohar (M-32) yrs S/o Late Man Bahadur Lohar of Dhap Goan, P.S. Shukhia Pokhiri, Dist. Darjeeling, is running such type of illegal business of selling illicit liquor without any valid documents for his wrongful gain. As the accused person namely Rajan Lohar (M-32) yrs S/o Late Man Bahadur Lohar of Dhap Goan, P.S. Shukhia Pokhiri, Dist. Darjeeling has violated the norms of Bengal Excise Act, further I seized the above noted articles under proper seizure list in presence of witnesses and after informing his ground of arrest I arrested the accused person under proper memo, and brought to the Pradhannagar PS to proceed further legal procedure. The whole process of search and seizure was made under the coverage of video graphs in between 15.05 hrs to 15.40 hrs at the spot as per norms of BNSS.

Therefore, I pray before your good self that a specific case may kindly be initiated against the accused person namely Rajan Lohar (M-32) yrs S/o Late Man Bahadur Lohar of Dhap Goan, P.S. Shukhia Pokhiri, Dist. Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
