It is to inform you that I, Debraj Das, S/O- Kartik Ch Das, DE & SM, Pradhannagar CCC; being empowered by the Electricity Act 2003, do hereby complain against ANITA RAI, W/O- Dipak Kumar Rai, Address- MN Saha Sarani, Ward No-02, P.S – Pradhannagar, Dist-Darjeeling, Pin-734003 for unauthorized use of domestic meter(SE0880070) of WBSEDCL for commercial purpose(which is a deemed disconnected premises having outstanding due).

Today i.e on 12.08.2025(13:45 hrs), I came to MN Saha Saranai (near Malhotra Tower), Ward No-02, Pin-734003; in my official hired vehicle for an inspection. I was accompanied by (i) Arijit Das, JE(Gr-II), Pradhannagar CCC, (ii) Rabi Shankar Singh, O.E, Pradhannagar CCC; (iii) Bhaben Roy, SO(S&LP), Darjeeling Region & other technical staffs of Pradhannagar CCC.

On inspection of the premises (after observing all formalities), I found that the meter SE0880070 (Domestic Category, Con Id- 403371518) is being used for commercial purposes (Aastha Medical). The premises of Aastha Medical was earlier rented out to Excel MRI & Health Services Pvt Ltd (Con Id-400602164, Deemed Disconnected, Disc Date-11.01.2024) which has an outstanding due of Rs.76789.70(LPSC -Rs.23709.056 as on 12.08.2025). Hence, electricity was unauthorizedly extended to a commercial and deemed premises by ANITA RAI.

Contractual load in the meter of ANITA RAI is 4.7KVA while the Maximum Demand in the meter is 6.04KVA. I disconnected the connection of ANITA RAI & seized the meter (SE0880070), after preparing the seizure list duly signed by the witnesses. Local people were present but none appeared. Seized Articles:

1 phase energy meter SE0880070,240V, 5-30A, Make-Schneider (L/R-4998)

ANITA RAI was not present at the premises. Her brother-in-law, received the copy of Notice, Inspection Note & Seizure

Hence, ANITA RAI is liable for prosecution U/S 135 1(e) of Electricity Act 2003 under I.E Act 2003.
