In producing herewith three (03) accused persons namely (i) Rahul Hussain @ Daku (25 yrs) S/O Nazrul Mia of Samar Nagar, Battala, PS- Pradhan Nagar, Dist. Darjeeling (2) Pawan Biswakarma @ Pol (25 yrs) S/O Prem Biswakarma of Thana Line, Kalchini, PS- Kalchini, Dist. Alipurduar and (3) Badal Chhetri (30 yrs) S/O Late Kalu Chhetri of Pradhan Nagar, Madari Hat, PS- Madari Hat, Dist. Alipurduar under arrest along with the following seizure articles viz:- (i) One sharp cutting weapon locally called as "HASUA" measuring approx 25 inches in length including its wooden butt, (ii) One iron made weapon locally called as "DEGAR" measuring 17 inches in length including its wooden Butt, (iii) One iron made rod locally called as "SABOL" measuring 24 inches in length, (iv) One iron made hummer measuring 13 inches in length including its iron handle, (v) One iron made instruments called as PLUS and (vi) One multi colour nynon bag.

I, SI Goutam Mallik of Pradhan Nagar PS, SPC do hereby lodge this written complaint against the above noted three (03) arrested accused persons and others 06/07 unknown miscreants who involve in this crime to the effect that on 12.08.2025 at 22.15 hrs I received a specific source information that about 09/10 miscreants equipped deadly weapons assembled in an abandand railway quarter at Himachal Colony under PS- Pradhan Nagar, Dist. Darjeeling and they are making preparations for committing Dacoity at Himachal Colony and its surrounding area. Accordingly, I diarized the fact in P.S. General diary vide Pradhan Nagar PS GDE No. 781 dated 12.08.2025 and informed the matter to you. As per your kind order and direction, I along with SI Bandhan Roy, ASI Prabal Sarkar, ASI Biplab Kr Das and force all of Pradhan Nagar PS, SPC left for Himachal Colony under PS- Pradhan Nagar, Dist.- Darjeeling by Govt. vehicle with investigation kits to verify the veracity of the information without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of a sensitive information and not to afford them opportunity for concealment of evidence or facility for their escape. I also informed night van officer SI Debabrata Khan of Pradhan Nagar PS and requested him to come to Himachal Colony to accompany us. On arrival at Himachal Colony Then, I requested two available independent witnesses namely (i) Krishna Sahani (32 yrs), S/O Upendar Sahani of Reajendra Nagar, Coolipara, ward no. 01, PS- Pradhan Nagar, Dist. Darjeeling and (ii) Krishna Dusadh (49 yrs) S/O Late Narayan Dusadh of Reajendra Nagar, Coolipara, ward no. 01, PS- Pradhan Nagar, Dist. Darjeeling and shared the information with them and requested them to remain present and act as witness if any search and seizure would be made, upon which they agreed. In the mean time night RT van officer SI Debabrata Khan along with is RT van force arrived at the spot and accompanied with us. I shared the information with them and briefed them properly. Then, I contacted my source and from a considerable distance he pointed to the place where the miscreants were assembled.

Thereafter, we proceeded towards the place being identified by the source and cordoned the place from every corner with due care and caution and from a considerable distance. We noticed that some persons were assembled at an abandoned railway quater, situated at Himachal Colony under PS- Pradhan Nagar, Dist. Darjeeling and they were whispering in a low voice. On seeing police personnel approaching towards them they tried to flee away from the spot but on hot chase we managed to apprehended above noted three (03) accused persons while 06/07 others unknown miscreants managed to flee away through others exit points, taking the advantage of darkness and heavy rain.

Thereafter, we disclosed our identities as Police personnel, we were in civil dress for our convenience). On interrogation, they disclosed their identities as noted above. On search recovered the above noted weapon of offence from their joint possession which they kept concealed inside one multi color nylon bag.

On further interrogation, they furnished incoherent statements and failed to give any satisfactory reply for their presence with deadly weapons in such deaf hour of night. Finally they disclosed that they along with 06/07 of their associates assembled there and were making preparations for committing Dacoity at Himachal Colony and its surrounding area. Accordingly, I seized the above mentioned weapons of offence from their joint possessions under proper seizure list in between 22.55 hrs to 23.30 hrs at the spot in presence of witnesses and duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. They are informed on the ground of their arrest. The whole process of search and seizure were made under the coverage of videography as per norms of BNSS and brought all the three (03) arrested accused persons along with seized articles to Pradhan Nagar Police Station for further investigation. From the above noted facts and seizure of incriminating articles there is strong reason to believe that all the above noted three (03) accused persons along with 06/07 of their associates who fled away, gathered there equipped deadly weapons at such deaf hour of night and taking preparation to commit Dacoity in a nearby affluent area at Himachal Colony.

Under the above circumstances, I pray before you that a specific case under proper section of law may kindly be started against the above noted three (03) arrested accused persons namely (i) Rahul Hussain @ Daku (25 yrs) S/O Nazrul Mia of Samar Nagar, Battala, PS- Pradhan Nagar, Dist. Darjeeling (2) Pawan Biswakarma @ Pol (25 yrs) S/O Prem Biswakarma of Thana Line, Kalchini, PS- Kalchini, Dist. Alipurduar and (3) Badal Chhetri (30 yrs) S/O Late Kalu Chhetri of Pradhan Nagar, Madari Hat, PS- Madari Hat, Dist. Alipurduar and others 06/07 unknown miscreants who fled away from the spot and arranged for its investigation.
