SUB-COMPLAINT LETTER

Respected Sir,

Most Humbly, I Smt. Jyoti Jordar, Wife of Sri Rony Jordar, resident of Khalpara, M.R.Road by lane, Ward no-7 of SMC, P.O & P.S-Siliguri, Dist-Darjeeling, do here by wire this complaint letter before you to stating that I residing along with my family above mention address(Red Light area) some Tenant are residing in my house in rental basis since 20 years, last few days ago some local goons of koyal depo(Vivekananda nagar) of ward no-7 came in our locality and create nuisance in our area as well as near my house they consuming drugs in locality, when I protest against their activity then they were threatened me badly, they want money from us as gundatax, last on dated-31-07-2025 person namely 1. Md.Subhan 2. S.K 3. Enter in my house illegally entered in my house in intoxicated condition and a girl namely **Komal Pandey** who residing at my house started giving him purposal for having sex with him but in that time she denied due to her health issue but Md.Subhan forcefully hold her tightly and take her into room and torn her cloth and started physically intimate with komal pandey forcefully without her concern assaulting sexually this girl hearing her sound I came out from my room and said them for leave my house but they started push me and abusing me in filthy languages suddenly they call some boys and persons namely Md.Raja son of late Md. Bechua and Md.Hussnain son of Md.Mumtaz reached near my house along with 20 to 30 persons all are resident of Koyla depo, Vivekananda nagar, who keep sharp weapons(khukri, knife, blade) and patro zar in their hands attack on my house they try to burn my house but local people save my house, they assaulting me physically in front of many peoples a person namely S.K Touch my body with bad intention when he touch my chest and I pushed him then he grab my hair and started slapped me and said "**tum bazaru aurat hai tumhara koi izzat nahi hai**" when my family persons try to save me they also assaulting my family members physically some boys try to torn my cloth also they attack upon my family members with sharp blade due to which we have some cut on neck and other body parts in bloody condition the same day we went to district hospital for treatment, when I came along with my family from the hospital then I found that they looted my

house and the next day I came to your police station for lodging my F.I.,R but due to some pressure of persons and all the said accused persons I did not lodge my complaint because they threatened me that if I lodge any police complaint against them then they kill me as well as my family members in scared situation I could not come again your police station for starting process This Case but after passing some days on dated-17/08/2025 around 9:00 pm at night they along with 10-15 goons came in my locality and saying filthy languages and demanding money from me (Gunda tax) as well as local girls when again I started protest again they started threatened me as well as the local people if we did not pay them then they create dispute every day in our locality in scared situation the local persons did not lodge any complaint before you they know that they can attack upon them in any time. They assaulting some sex workers.physically, sexually and mentally everyday they snatched money from them. The persons namely 1. Samsad 2. Iqbal 3. Md.Subhan 4. S.K 5. Md.Raja son of late Md. Bechua and Md.Hussnain son of Md.Mumtaz and around 10-15 boys (Name Unknown)are the main culprits they came around 9 pm at every night in intoxicated situation and create all the situation as well as today they again threatened me when I passing by the Vivekananda Road.

Now I am very hopeless and living in scared atmosphere in my locality, so lastly I came before to you In This Situation and requested to you that kindly please take some strict action against all the persons. I am highly obliged with you.
