I Sapna Begam (30), the above noted Complainant, beg to inform you that I was previously known to Chandni Keshwari w/o Rajkumar and was residing at Turki wali Gali, Cham Nagar, Asfabad, P.S. & Distt.-Firoza Bad (U.P.), and I started working as sex worker at Khatyana Redlight area, at the brotch of Charas, few years back, but I left redlight area and nearly 10 (ten) days back and started living in a rented house at the house of 40 Md. Aslam, Medical More, P.S.-Muhigara, Distt.-Dajepaly.

On 01.19.08.2025, I came to Thakur more, to take money from one of my familiar persons, at about 07.00 pm, and, the above noted present sex worker namely, Puckki, who work in the brotch of Begam w/o Charas, meet me and requested me to go to Redlight area to meet with others, and trusting upon her I went to Khatyana Redlight area, at the brotch of Sund Charas, but when I reached there, he locked me in their room and started abusing me in filthy languages and when I protested, they started beating me brutally with fist & blows and above noted Ritu who is also a sex worker, throttled my throat with intention to kill me and they broken my 02 (two) mobile phones, and outraged my modesty.

Sir, the above noted alleged persons are of very desperate & dangerous in nature and they have threatened me for more consequences.

I immediately shifted to Sulejani Distt. Hospital and treated myself there so, please take necessary action against above noted alleged persons.
