Respected Sir,

I SMT. MADHUMITA MANDAL (GHOSH), W/O Sri Sona Mandal, presently residing at Chunabhati, Purba Dhantala, Phulbari, P.S. New Jalpaiguri, Dist. Jalpaiguri, wish to lodge this complaint against my husband 1. Sri Sona Mandal, S/o Sri Rabi Mandal, my father - in - law 2. Sri Rabi Mandal, my mother - in - law 3. Smt. Kanika Mandal, W/o Sri Rabi Mandal, all are residing at Chunabhati, Purba Dhantala, Phulbari, P.S. New Jalpaiguri, Dist. Jalpaiguri and my sister - in - law 4. Smt. Rupa Dey, W/o Sri Prasenjit Dey, residing at Kauyakhali, Medical, P.S. Matigara, Dist. Darjeeling for committing heinous acts of cruelty, abuse, dowry demand and attempt to murder.

1. Since my marriage on 31/01/2024 my husband and above named in laws have been subjecting me to continuous physical and mental cruelty. At the time of marriage my parents gave Rs. 2 Lakhs cash to my in laws as dowry.

Now, ^{they} have been continuously demanding 5 lakhs, gold and other valuable articles from my parents. Despite fulfilling many of their unjust demands, they remained dissatisfied and continued torturing me.

On several occasions I was physically assaulted and abused in filthy language by my husband and in laws. Recently on 19/08/2025 in the morning at about 10:00 A.M. my husband and in laws assaulted me and beat me mercilessly, abused me with filthy languages and my husband tried to strangle me by holding my neck with an intention to kill me. I struggled to free myself and survived narrowly. They also threatened me with dire consequences if I disclosed the matter to anyone.

Therefore hereby request you to kindly register my complaint as an F.I.R. and direct legal action against all the accused persons and ensure my safety and protection from further harm.
