I, Smt. Jyoti Gupta, daughter of Munna Gupta, resident of Samar Nagar, Bartalla, Dj More, P.O. Champasari, P.S. Pradhan Nagar, Dist: Darjeeling, in the States of West Bengal.

I beg to inform you that I got married on 07/02/2025 with one Ashis Kumar Gupta at Hotel Gopal Heights, Champasari, and at the time of marriage my parents gave cash amounting to Rs. 3,00,000/- (Three Lakhs) Only via Bank Transfer and Gold Ornaments amounting to Rs. 4,00,000/- (Four Lakhs) and Furniture amounting to Rs. 1,80,000/- (One Lakh Eighty Thousand) Only and spended around Rs.5,00,000/- (Five Lakhs) Only in the marriage for fooding and lodging and after the marriage ceremony I was taken to Bihar at the residence of my husband i.e. P.O. Khartari, Chiriya More, Purbi Champaran, Bihar, Pin - 845415. That right after the marriage I was subject to mental and physical tourcher and I was never allowed to talk to my parents and was also not allowed to come out of the house and was never given food on time to eat I was given all the left over foods to eat and even the in-laws namely Dinesh Gupta (Father In-Law), Sarita Gupta (Mother In-Law), Manish Gupta (Brother In-Law), Manisha Gupta (Sister In-Law) use to tourcher me day and night. And my husband use to chat with my friends and family being me using my mobile phone and after giving so much they further demand for more dowery.

That it would not be out of place to mention here that my husband puse to have physical relationship with me even if I did not wanted to and I was never allowed to sleep well at night my husband use to kick me or pinch me whenever I use to fall asleep and right after one month of marriage I was pregnant but after knowing about my pregnancy my mother in-law gave me sour curd with some added medicines because of which I suffered bleeding and miscarriage and again after 3 months I was pregnant but this time my husband bought some medicine and said it's a vitamin tables and asked to take it and then after taking the medicine within 24 hrs I had bleeding and suffered miscarriage.

That after several request made by my parents to my husband and inlaws they allowed me to come and see my parents and on 10th of this month I came down to Siliguri with my husband and I was not allowed to carry any of my belongings and all my Stridhan and Clothes are at my husband's place i.e. in Bihar, when I came to Siliguri and after seeing my condition my parents were shocked and even at my parents house at Samar Nagar my husband assaulted me with fist and blows and because of this I am seriously ill and yesterday on 15th August I was not able to stand as I am very weak due to the assault and mental tourcher my father took me to Hospital where the Doctor have advised me to get admitted in the hospital for further treatment.

Then when my parents narrated the facts to my husband and in-laws they started threatening me and my family members that they would kill us as they are very dangerous and they also have illegal arms and weapons at their residence in Bihar and is asking me to come urgently or else they would come to Siliguri and kill me and my family.

Therefore I request you to kindly look into the matter and take necessary action against the husband and in-laws of my daughter as soon as possible as we are in very much fear and not able to see the condition of my daughter hence having no other option I have come before your office for justice.
