Sir.

In producing herewith the following seized articles as per seizure list viz:- (i) one goods carriyer vehicle (Tractor) displaying Registration number WB/85/3560 loaded with illegally mined river bed materials and (ii) one goods carriyer vehicle (Truck) displaying Registration number WBY/4641 loaded with illegally mined river bed materials. I, ASI Bikash Roy of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the driver and owner of the above mentioned seized 02 (two) vehicles having registration number (i) WB/85/3560 and (ii) WBY/4641 to the effect that today on 18.08.25 at about 16.50 hrs I received specific source information that two vehicles loaded with illegally mained river bed Materials is coming from Samar Nagar Military Ghat and prodeceding towards Narmada Bagan side with a view to sale the same to their design customers for their illegal gain. Accordingly, I diarized the fact in PS General Diary vide Pradhan Nagar PS GDE No 1112 dated 18.08.25 and informed the fact to you. As per your kind order and direction myself along with force left for Narmada Bagan side under PS- Pradhan Nagar, Dist. Darjeeling by Govt vehicle to verify the veracity of the information.

On the way to Narmada Bagan the source informed that the said vehicle loaded with illegal river bed materials proceeding towards Narmada Bagar side. At around 17.05 hrs we reached at Narmada Bagan under PS- Pradhan Nagar, Dist. Darjeeling and from a considerable we noticed that two vehicles (one truck and one tractor) were coming towards Narmada Bagan side but seeing the police van drivers of both the vehicles stopped their vehicles beside the road at Narmada Bagan under PS- Pradhan Nagar, Dist.- Darjeeling and started to flee away. We tried our level best to apprehend them but they managed to flee away from the spot. Then we searched both the vehicles and found both the vehicle loaded with illegal river bed materials. I searched the owner and driver of the vehicle but nobody came forward to claim the vehicles. Held local enquiry it could be revealed that the driver and owner of both the vehicles mined river bed materials from Mahananda River by illegal means and loaded the same in their vehicles with a view to sale the same to their designed customers for their wrongful gain. Accordinggly, I seized both above mentioned vehicles having registration number WB/85/3560 and WBY/4641 loaded with illegally mined river bed materials under proper seizure list in between 17.25 hrs to 17.55 hrs under the coverage of videography and brought to Pradhan Nagar PS for further investigation.

Under the above noted fact and circumstance, I, therefore pray before your good self that a specific case may kindly be initiated against the driver and owner of both the seized vehicle having registration number WB/85/3560 and WBY/4641 under proper section of law and may arrange to cause its investigation.
