you that - I was married with my husband (Israel Atam) as per
Muslim rite for 10 years but after 9 or 10 years my husband
tortured both physically and mentally and assault with without
any reason.

I managed to stay with him and give several times chance
to him but he did not pay any heed of my word. He also
doubt upon me say that I have affair with other persons. On
15 Aug 2025 to 18 Aug 2025 when I came at night from my
duty, he started assaulting and beaten badly. He used blade
to beat and threatened me with dire consequence.
He also say that - "Jada mat bho. Kab tunko mar ke
for denge para hi orahi chalega".

When every my family member want to talk with me
then he use strong and threat as well as use filthy language
containing he physically assault three (03) day from 15 Aug
to 18 Aug 2025 and for that I received sustained injury on
my body.

Therefore, I will be very glad if you consider my prayer
and take necessary legal action against him.
