Dear Sir,

I, Sri Abhishek Roy, S/O Jagadish Ch Roy, Station Manager, Customer Care Centre Matigara, WBSEDCL, P.S Matigara do here by lodge this complain empowered by Electricity ACT 2003 (amendment act 2007) to the effect that, Sobi Rumba W/O Pemba Rumba residing in Tapasya Aparment, Ashram Road, Methibari, Salbari Darjeeling, she has committed use of electricity illegally under section 135 (1) (e) of electricity Act 2003.

On dated 20.08.2025 at 13:40 hr I along with accompanying WBSEDCL team viz. 1) Bhaben Roy S.O S&LP of Darjeeling Regional Office, WBSEDCL, 2) Bijay Lakra, SE & S&LP Darjeeling Regional Office, WBSEDCL 3) Patilal Rai of Matigara CCC, 4) Sanjoy Ram of Matigara CCC have entered the premise of Sobi Rumba at Tapasya Apartment, Salbari. During inspection it has been found that from domestic purpose meter L1537209 of Sobi Rumba commercial use is going on to commercial shop named Dada Bhai Medical Store, C/O Masarab Hussain in which outstanding dues of Dhananjoy Roy Con Id 402513472 exists. Accessed load of electricity illegally enjoyed by them is 2.78 KW. The findings are incorporated in the inspection report prepared at site. This activity is going on for six monthes.

Hence prepare an inspection memo by mentioning all minute details, as observed and also seized the meter and 6 sqmm pvc cable approx. 41 meter length in question after preparing the proper serial list duly signed by witnesses and representative of the premise owner. Supply copies of required documents to the representative for future reference. Remove the meter from the place after observing all technical formalities. The inspection team left the said premises at 14.00 hrs on date.

So it is requested that a case under section 135 (1) (e) against Sobi Rumba may please be registered and arrange for its investigation.
