BIMAL BISWAS SON of ANIL BISWAS a residence of TALIPARA, PO:- GHOGOMALI, PIN:- 734006, near:- Barada School for recovery of outstanding dues of loan no:- P521PDP36243145, as his first instalment was found unpaid till date, despite of several prior discussion and physical visit during official hours.

In pertent to, customer and his friend today 19/08/25 at 19:00hr has appeared in an intoxicated state and started verbal abuse.

CONTINUE:-

Suddenly they started to physically assaulting us with sharp objects and steel bangles and drinking glass bottle which was projected on us to make a high physical damage/injury with intend to snatch our existing recovery amount of 18,765 Rs of others Customer repayment amount. to utilise the same with his friend present over there for their night party as heard while assaulting.

I, biswajit was kicked and slapped and got beaten in my right hand back and on my lower back and abdomen.

In order to rescue me, my agency owner named Ratan Kumar Brahma also got beaten by Customer and his friend badly in face and also throwing brick to hit on his head for critical damage. Both of us got traumatised with this incident. for which medical Certificate from Siliguri Government hospital attached for reference.

I would like to treat this Complaint as first information Report regarding and kindly take necessary action as per law against the Said persons for the assault and obstruction in the

Course of my official duty cause heinous
Physical injuries.
