Sir,

With reference to the subject cited above, this is to report a case of missing of vital telecom equipment from the BSNL BTS site located at GHOGOMALI.

As the aforementioned site was down since 12:45 am (approx.) of 20.08.2025, team of technicians from M/s TCS visited the aforesaid site for restoration purpose on 21.08.2025, it was discovered that unknown miscreant(s) had illegally gained access to the BTS premises and subsequently the following critical equipment is missing: -

1. Power Cable – 90 meters.

The site appeared to have been tampered with. The aforesaid unauthorized entry has severely damaged the telecom infrastructure and disrupted very important mobile connectivity in the area, affecting essential communication services.

As per the instructions of the higher authorities in BSNL, this written report is being submitted after discovery of missing equipment. We request that you kindly register the incident and initiate necessary legal action, including investigation and recovery steps. We also request the issuance of a General Diary (GD) number / CSR copy for our official records and for submission to our higher authorities please.
