On 19.08.2025 a written complaint was received from one Raj Kumar Agarwal of Green Vista Apartent, 1st Floor, Block-5, Flat No. C1, Ward No. 43, PS Bhaktinagar, Dist. Jalpaiguri to the effect that his son Pratik Agarwal @ Bunty was found dead in his room. Approx at 12.30 hrs his mother Lalita Devi Agarwal received a call from him saying "mera kaam hogaya main jaon'. She then called his wife who immediately rushed to the home and found the door locked from inside. Then she called her staff and broke the door and found him covered in blood and had committed suicide by firing himself by a firearm.

Accordingly, on the basis of above noted complaint a UD case was initiated vide Bhaktinagar PS UD Case No. 54/25 Dtd. 19.08.2025 and endorsed to me for it enquiry. During enquiry, I visited the PO and observed all formalities of UD Case and forwarded the dead body of the deceased to the Head of the Department, Forsensic Medicine, NBMC & H to ascertain the actual cause of death.

During enquiry I also seized the following articles from the PO:

- i) O1 (One) Steel made pistol with 01 (One) empty magazine without any company marking and Sl. No.
- ii) One empty case of bullet mark as KF and other letter are illegible.
- iii) One black colour I-phone.
- iv) One Samsung Mobile phone.
- v) One eye glass (spectacle).
- vi) One door latch holder (black colour) attached two iron screw.

It was revealed during preliminary enquiry that the deceased Pratik Agarwal @ Bunty had procured the above seized improvised pistol to commit suicide. On further enquiry the family of the deceased was unaware of the possession of said pistol and they could not produce any license/documents in respect of the said pistol.

On the above noted circumstance I pray before your kind self that a specific case may kindly be initiated for ascertaining the source of procurement of said firearm.
