Sir,

I, SMT. TAPASHI MANDAL, W/o Sri MANOJ KUMAR MANDAL, D/o Sri Ram Chandra Das, resident of Near Bishwa Bandhu Kali Bari Ground, West Hatiyadanga, P.O. Shaudangi Hat, P.S. Bhaktinagar, District- Jalpaiguri in the State of West Bengal, would like to lodge this Written Complaint to the effect that my marriage was solemnized on 13.03.2020 with one Manoj Kumar Mandal, Son of Goutam Mandal resident of Near Bishwa Bandhu Kali Bari Ground, West Hatiyadanga, P.O. Shaudangi Hat, P.S. Bhaktinagar, District- Jalpaiguri in the State of West Bengal on and from my parental house situated at Telipara, Ashighar, P.O. Ghogomali, P.S. Bhaktinagar, District- Jalpaiguri by observing all formalities of Hindu Marriage and after the marriage I came to my matrimonial house and our marriage was duly consummated.

Sir, it is to be mentioned here that the marriage was the outcome of the previous love and affairs and thereafter the marriage was negotiated between the parties.

Sir, it is to be mentioned here soon after the marriage my husband Manoj Kumar Mandal started to demand Rs. 5,00,000/- (Rupees Five Lakh) only and gold chain and golden ring for him and my father somehow managed and gave gold jeweleries as per his demand and even after the delivery of gold from my father he used to pressurize me on regular basis to bring Rs. 5,00,000/- (Rupees Five Lakh) only as he wanted to start a new business and my father had given the Rs. 5,00,000/- (Rupees Five Lakh) only for the purpose of my happy conjugal life.

Sir, my husband used to assault me physically on regular basis and he used to abuse me very filthy language and he used to pressurize me and on November, 2024 I became pregnant and I was so happy for that and when I informed the same to my husband he became furious and assaulted me and kicked on my stomach and as such I sustained severe pain in my lower

abdomen and on 11/12/2024 at night he brought some medicines namely Mifegest and forcefully feed me and due to such act I suffered miscarriage.

Sir, soon after my miscarriage, my husband above named threatened me to not to complaining about the incident before Police or anyone. It is to be mentioned here that again in the month of march, 2025, I again become pregnant and this time again he started to pressurize me for terminating the pregnancy and when I denied to do any such act he again assaulted me badly before my in-law members and when my father in-law tried to stop my husband he also pushed my father in-law and others and left the house.

Sir, after the above mentioned incident he frequently used to stay outside the house and whereabouts best known to him and whenever I and my father in-law and mother in-law requested him to come back to the house he used to say that he will come back to the house only if I terminate my pregnancy.

Sir, on 09.08.2025 he came to the matrimonial house with a lady namely Purnima Roy, D/o Mahesh Roy, resident of Jaleshwari Bazar, Mohim Colony, P.O. Sahudangi Hat, P.S. Bhaktinagar, Dist- Jalpaiguri and tried to enter forcefully into the house but my father in-law and other neighbors raised their objection upon such wrongful act of my husband and Purnima Roy, but my husband was continuously threatened to oust me by saying that he will marry Purnima Roy and oust me from my matrimonial house and on 11.08.2025 my husband married Purnima Roy and he called me over phone and threatened me to kill me as well as my unborn child and the same incident was diarized before the O/C Ashighar Police Station and one Specific Case has been registered vide Bhaktinagar PS Case No. 785/2025, dated. 10.08.2025.

Sir, today at about 10:00 AM in the morning my husband came to the matrimonial house and my husband knocked my door and enter into the bedroom and trying to convince me to have/eat Mifegest medicine for causing miscarriage to me and when I shouted and tried to raise my voice my husband pressed my mouth and suddenly Purnima Roy also entered into the room and she caught the hold of my both foot and my husband was trying to strangulate me by pressing my throat and hearing the hue and cry my Father in-Law and Mother in-law and other neighbor came to rescue me but my husband was continuously kicking on my stomach by shouting that "aajke

toke aar tor bacha ke, Sobaikei mere felbo aar amar bou Purnima ke niye ei baaritei thakbo" and in course of assaulting Purnima pull out a knife from her pocket and attacked on my body with an intention to kill me but my in-laws rescued me from both of them and they left the place by threatening that they will oust me and kill me and my unborn child.

Sir, I am in great fear that my husband and Purnima Roy again come and kill me and my unborn child.

Sir, it is to be mentioned here that the above mentioned Purnima Roy is a lady of bad character and she has many criminal antecedents and she is very dangerous and desperate lady, in above situation I am in great fear and panic.

Therefore, in such situation I am in great fear and taking the shelter of law, Kindly do needful as per law against the wrongdoers.
