Most Humbly, I **Asif Khan**, Son of Zafiruddin Khan, Resident of Dangi Para, ward no-6 of SMC, P.O & P.S-Siliguri, Dist-Darjeeling, do here by inform you that I am a reputed business man having shop at vivekankanda nagar, ward no-7 of SMC, Under Siliguri Police Station, further I inform you that ago some days a dispute create between my law's house and the some anti social elements my sister in law lodge a police complaint yesterday and when they getting this information some anti social elements namely **1.Musturi Khatun wife of Lt.Ahmed @ bechua 2. Md.Raja son of Lt.Ahmed @ bechua** they along with 5 to 10 persons of koyladepo Vivekananda nagar, are reached at my shop yesterday on dated-20/08/2025 around 8:30 pm at night and create pressure upon me to said my law's to withdraw the police case but I refuse and said them that I have no connection with all this incident and I can't do this but suddenly they started threatened me, abusing me in filthy languages, they grab my collar and out me from my shop, started assaulting me physically in front of local people, some persons looted some cash from my shop around Rs.3200/- in cash from cash counter, they snatched my money around Rs.3000/- (Three thousand) which I was kept in my pocket as well as a gold chain from my neck, other shop keeper saved me from them yesterday They said that if I don't pressurized my in law's for withdraw the police case then they implicated false police case of women modesty, rape and physically assaulting and other criminal allegation.

So I inform you that please do necessary step from your ends and take strict action against all this culprit person and specially against lady namely Musturi Khatun who taking benefits of her gender by using wrong allegation to any person and implicate false police complaint.
