Sir,

With due respect I would like to inform you that I work as a dealing boy under a band leader at the Hotel Grand Gateway situated at Sevoke Road Siliguri. As usual I completed my work and I was on the way to my house at Iskon Road around 03.10am(I was late as it was raining heavily and I was riding my scooty). Suddenly as I reached near bazaar Kolkata sevoke road a group of people stopped me and asked to surrender my valuables. As I tried to stop them they pulled me down my scooty and forced me to sit on their bikes and one among them was riding m scooty till we reached khalpara more. They took away my mobile so that I may not contact anyone and demanded a huge amount of cash. I was slapped a number of times and they continuously threatened me of killing me if I don't fulfil them their demands. I was so scared that I handed them the cash I had at that time which was around 17,750/=(Rupees Seventeen Thousand Seven Hundred and Fifty only) They were not satisfied with that and I was still beaten until and unless I transferred them amount of Rs 20,000/=(Twenty Thousand Only) via Google Pay in the mobile number 9064800870 and the name appeared on the screen was Satya Khan.

They were continuously pushing me and tried to snatch my gold chain (around 16 gram) and in this manner I lost it and I hope anyone among them have carried it with them. I was allowed to move by around 05.40 in the morning but they damaged my scooty so badly that I could not ride it and I dragged it till my house .I moved to the garage and estimated around 21000/=(Twenty one thousand) to repair it.

Sir, as I work under a very low wages and I have lost the following things in a very short time without any reason I would request you to take necessary action so that I may recover the loss and no one else in this town may be harassed like me in the main town.
