I, Sri Tapas Bishui, Divisional Engineer (E) & Station Manager, Hakimpara CCC, WBSEDCL, Siliguri do here by lodge complaint against Ratan Saha, S/O- Lt. Sachindra Lal Saha, A/105, Gouri Shankar Market, Bidhan Road, Siliguri, P.S.- Siliguri, Dist- Darjeeling for having committed offence as stated here under.

On 22.08.2025 at about 01.25 p.m. acting on a source information I, along with (1) Sri Bijay Lakra, D.E., S&LP Wing, Darjeeling Region, WBSEDCL, (2) Sri Bhaben Roy, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (3) Sri Biswajit Ghosh, Linesman, Hakimpara CCC and other officials of WBSEDCL entered the commercial premises of Ratan Saha and inspected service installation, metering installation of Consumer ID 412057502 in the name of Ratan Saha. During inspection it was found that user Ratan Saha supplying electricity from the energy meter of Consumer ID 412057502 unauthorisedly and illegally to the disconnected & defaulted premises of Consumer ID 412057510 in the name of Sri Satyajit Saha that was disconnected previously on 19.03.2013 due to non-payment of outstanding energy bill.

As unauthorised supply of electricity to the disconnected & defaulted premises was detected the energy meter make Landies & Gyer Ltd, serial no.- L251684 installed against Con Id. 412057502 seized by preparing a formal seizure list duly signed by representative of Ratan Saha and witnesses. The copy of the seizure list handed over to representative of Ratan Saha and his signature obtained as token of receipt.

As Ratan Saha have committed offence u/s 135(1)(e) of Electricity Act 2003 by supplying electricity illegally & unauthorisedly to the disconnected & defaulted premises, you are requested to take cognizance of the same by treating this complaint as FIR. The seized articles are packed and labelled by me.
