Sir,

In producing herewith following three accused persons named (i) Rohit Thakur, aged 24 years, s/o- Somnath Thakur resident of Harekrishna Pally, PS- Bagdogra, Dist- Darjeeling, (ii) Biswat Oraon, aged 21 years, s/o- Late Nishi Oraon, resident of Kamalpur T.E, Bich Line, PS- Bagdogra, Dist- Darjeeling and (iii) Chhotu Munda, aged 35 years, s/o- Late Sukhan Munda, resident of Kamalpur T.E, Bich Line, PS- Bagdogra, Dist- Darjeeling (not verified) under custody along with following seized articles:

- (i) One iron-made crowbar (shabal) measuring approx length 2'6" recovered & seized from the possession of Chhotu Munda and marked as Exhibit-A.
- (ii) One steel-made screw driver with green colour handle recovered & seized from the possession of Biswat Oraon and marked as Exhibit-B.
- (iii) One black colour torch light made of aluminum & plastic styled as "JYSUPER" recovered & seized from the possession of Rohit Thakur and marked as Exhibit-C.
- (iv) One navy blue colour backpack styled as "JANSPORT" kept lying on the floor and marked as Exhibit-D.
- (v) One iron-made "Kalam Chhuri" measuring approx length 1'4" including wooden butt approx length 6' and marked as Exhibit-E.
- (vi) One nylon rope measuring approx length 15' and marked as Exhibit-F.

[Note: Exhibit-E & Exhibit-F were kept concealed inside Exhibit-D]

I, ASI Amit Lama of Bagdogra PS, SPC, do hereby lodge this written complaint against the above noted arrested three involved accused persons and other 4/5 absconding unknown miscreants to the effect that today on 19.08.2025 at 00:15 hrs I received reliable source information that some suspects have assembled in a tea stall beside NH-31, Kolkata Road under Bagdogra PS with a preparation to commit dacoity at Bhuttabari area. Accordingly, I informed the matter to O/C Bagdogra PS and diarized the matter in GD vide Bagdogra PS GDE No. 849 dated 19.08.2025. Then as per direction of O/C Bagdogra PS, I formed a raiding team consisting SI Debabrata Kundu, C/1509 Sourav Roy Sarkar, CV/389 Janak Singh & CV/375 Jogesh Barman leaded by me. Then at 00:20 hrs as per direction of O/C Bagdogra PS, we left for the tea stall beside NH-31, Kolkata Road under Bagdogra PS by Govt. vehicle No. WB61A/0137 to work out the secret source information. This refers to Bagdogra PS GDE No. 850 dated 19.08.2025. At around 00:30 hrs we reached near a tea stall beside NH-31, Kolkata Road and made an ambush there and waited for source indication. We parked our Govt. vehicle away from the place. In the mean time, source indicated us the group of suspects. There were a group of about 7/8 suspects. Then, being shown & indication by source we started to cordon them from all side. All on a sudden some of them noticed us and tried to flee away from the spot. But after hot chase with the help of accompanying Police team we managed to apprehend three suspects there in red-handed at around 00:35 hrs. We searched for independent witnesses. One independent witness named MD. Jaminul, aged 24 years, s/o- Late MD. Mofijuddin, resident of Digravita, PS- Bagdogra, Dist- Darjeeling (PH. No. 95474-87800) agreed to be present there. Accordingly, I arranged to search their persons. On search, one crowbar (shabal), one screw driver, one torch light, one backpack, nylon rope and one torch light were recovered from their joint possession. Accordingly, I interrogated them. On interrogation, they could not give any satisfactory answer regarding their presence at that place at the odd hours of night. They gave different statement in different times. Finally, they revealed their identity as (i) Rohit Thakur, aged 24 years, s/o- Somnath Thakur resident of Harekrishna Pally, PS- Bagdogra, Dist- Darjeeling, (ii) Biswat Oraon, aged 21 years, s/o- Late Nishi Oraon, resident of Kamalpur T.E, Bich Line, PS- Bagdogra, Dist- Darjeeling and (iii) Chhotu Munda,
