I request you to kindly register my complaint as a FIR under the appropriate sections of the Bharatiya Nyaya Sanhita section 316 (Cheating AND Dishonestly inducing delivery of property).

Section 308 (Criminal breach of trust) and Sections 336 (addresses the offence of forgery) It defines forgery as the act of making a false documents or electronic record with the intend to cause, damage, fraud, injury or to support a false claim or title and any other relevant provisions as per your investigations.

I am ready to provide any further details or evidence you required kindly take Immediate action help bring the accused under the law.
