construct the same but they did not paid any
heed to it and started abusing me and my
husband with filthy languages hearing all this my
son Namely Rohit Yadav came to the spot
and told them not to do the same but then
Baijnath Paswan along with his 2 sons Namely
Soumen Paswan s/o Baijnath Paswan R/o do
& Abhay Paswan s/o do, R/o do became very aggressive
and vicious and started assaulting all of us
Sir it is very Important to Mention here that
they not only brutally assaulted me with fist and
slaps but also hit me and my son with
construction equipment with great motive and
intention of killing us on the spot but with the
grace of God I am how we escaped but they
