I, Dr. Prabir Nandi, Headmaster of Ranidanga Kalaram High School (H.S.), wish to report that an incident of theft occurred within the school premises between 12:30 a.m. and 1:30 a.m. on 7th August 2025.

An unidentified person unlawfully entered the premises by scaling the boundary wall, broke several locks, and forcibly entered approximately two rooms and one bathroom. The following items were stolen:

1. One water pump (Havells, 1 HP, MP One model, approximately six months old)
2. One "Sabooj Sathi" bicycle

In addition, certain school property was damaged during the incident.

The incident was captured by CCTV, and some relevant footage is available for your consideration.

In this regard, I kindly request you to lodge an F.I.R. against the unidentified offender(s) and take necessary action to recover the stolen items and prevent any further unlawful activities within the school premises.
