## Subject: FIR

Inspector-In-Charge Matigara Police Station

Sir.

In producing herewith three (03) arrested accused persons namely 1) Sonu Balmiki (M/29)S/O- Late Kishor Balmiki of Baghajatin Colony,Radhakrishna Mandir, PO+PS- Pradhannagar, Dist- Darjeeling 2) Tushar Barman (M/29) S/O-Bhupen Barman of Rabindrasarani, PO- Kadamtala, PS- Matigara, Dist- Darjeeling 3)Sukumar Das (M/24) S/O- Gouranga Das of Charakmath, Ward No-04,PO- Siliguri Bazar, PS- Siliguri, Dist- Darjeeling arrested u/s- 35 of B.N.S.S along with following seized articles viz:

- (1) One Iron made hammer (house breaking implement) measuring about 20 inches in length from the possession of Sukumar Das which was kept on his left hand.
- (2) One SABAL (iron made house breaking implement) measuring about 03 feet in length from the possession of Sonu Balmiki which was kept on his right
- (3) One Torch Light from the possession of Tushar Barman.
- (4) One bottle of 60 UP Himalayan Gold liquor from the possession of Sonu Balmiki.

I, ASI Bhanu Pradhan of NBMC OP under Matigara P.S, Siliguri Police Commissionerate-do hereby lodge this complaint against the above noted accused persons and others to the effect that on 23.08.24 at 00.25 hrs received a source information that 10/12 youths have assembled at back side of Desun Hospital under Matigara PS with a view to commit dacoity at Kawakhali area. The fact was diarized in GDE vide NBMC OP GDE No- 808 dated 23.08.25. Subsequently, after sharing the information with my superiors and as per their direction, I along with ASI Krishnendu Roy, ASI Amal Roy and force C/1085 Mithun Debnath, C/340 Pranab Adhikary left for the place to work out the information with Govt vehicle bearing registration no WB 02 AT 2965. This refers to NBMC OP GDE No-809, dated-23.08.2025. On way we called two disinterested persons namely Mithun Singha(39) \$/O- Lt. Baldev Singha of Kawakhali, PO- Sushrutanagar, PS. Matigara, Dist. Darjeeling and Santosh Barman (36) S/O-Tarani Barman of Rupsingjote. P.S-Bagdogra, Dist: Darjeeling and to whom we disclosed our identity and asked them to accompany us if any search and seizure is necessary for the purpose.

At about 00.45 hrs after reaching at back side of Desun Hospital under Matigara PS, I met my source and as pointed by the source we started approaching towards the spot and cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence. But, seeing the police party approaching towards them they tried to flee away from the spot. On hot chase we managed to apprehend three accused persons along with seized articles from their possession as mentioned above who disclosed their name & address as 1) Sonu Balmiki (M/29)S/O- Late Kishor Balmiki of Baghajatin Colony, Radhakrishna Mandir, PO+PS- Pradhannagar, DistDarjeeling 2) Tushar Barman (M/29) S/O- Bhupen Barman of Rabindrasarani,PO- Kadamtala, PS- Matigara, Dist- Darjeeling 3)Sukumar Das (M/24) S/O- Gouranga Das of Charakmath, Ward No-04,PO- Siliguri Bazar, PS- Siliguri, Dist- Darjeeling

However the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there and were planning to commit dacoity at Kawakhali area. They also stated that other persons namely Shiba Das, Roni Majumder, Gourab, Shib Chowdhury, and other four persons also with them who managed to fled away from there.

I thereafter, seized the above noted weapons & torch light under proper seizure in presence of witnesses and being acknowledged by the accused persons. The whole process of search, seizure was made in between 00.55 hrs to 01.20 hrs with videography on 23.08.25. Thereafter, I arrested the above noted accused persons u/s 35 BNSS under proper memo of arrests duly signed by the accused persons.

Hence, a specific case may kindly be started under proper section of law against the above noted accused persons namely 1) Sonu Balmiki (M/29)S/O- Late Kishor Balmiki of Baghajatin Colony,Radhakrishna Mandir,PO+PS- Pradhannagar, Dist- Darjeeling 2) Tushar Barman (M/29) S/O- Bhupen Barman of Rabindrasarani,PO- Kadamtala, PS- Matigara, Dist- Darjeeling 3)Sukumar Das (M/24) S/O- Gouranga Das of Charakmath, Ward No-04,PO- Siliguri Bazar, PS-Siliguri, Dist- Darjeeling and others and arrange for its investigation.
