Respected Sir,

With due respect I, AKHBARI KHATOON, Wife of Late Md. Mustafa, Resident of Darbanga Tola, under Ward no. 6 of S.M.C., P.O. & P.S. - Siliguri, District-Darjeeling, would like to inform you that I am an old aged and ill woman. Sir on 22/08/2025 at about 2:45 P.M. suddenly Mariyam Khatoon, Wife of Md. Akbar, Md. Akbar, Son of Unknown, Nazneen Khatoon, Daughter of Md. Akhtar, Sakina Begum, Wife of Md. Akhtar, Ayesha Begum, W/o Md. Akbar, Parveen Khatoon, D/o Md. Akhtar, Shaheen Asgar, Wife of Md. Moine, suddenly came to entrance of my house in view of assassinated our family members and after opening the door they started quarrel with me and my daughter namely Beby Hena and thereafter Mariyam Khatoon pushed me and used criminal force upon me and used filthy languages upon us and thereafter they started misbehaving with my daughter and told about her gesture to insult her modesty. Thereafter they assaulted me and my daughter brutally by kicks and fists on our face and body and tried to kill us. As such we suffered several injuries at my forehead, chest and other part of body. They also snatched gold chain from the neck of my daughter namely Beby Hena. Said Mariyam Khatoon, Md. Akbar and Parveen Khatoon tore her cloth and outraged the modesty of my daughter and her hairs also snatched, pulled and dragged by them, Subsequently my daughter bleed out and she fall down unconsciously, thereafter I took my daughter to Siliguri Sub-Divisional Hospital, then Doctor advised to admit her and I admitted her to Siliguri Sub- Divisional Hospital on 22/08/2025 and thereafter she discharged on 23/08/2025 in spite of her bad condition as my daughter have three small children as no one is available for look after them.

Sir they did this type of offences several times and several cases (Siliguri P.S. Case no. 400/2025 etc.) were also pending upon them. Sir it is our apprehension that they will again take any illegal acts in future as they are habitual offenders. Our family members are now living in fear of their acts. They also told us renowned political persons and police authority are in his pocket no one can take any action against them.

Therefore I requested you to investigate into the matter and to take legal action against those persons so that they would be punished as per law and thereby I shall be obliged to you.
