Sir,

In producing herewith following seized articles as per seizure list viz :- (i) One blue colour tractor styled as "Sonalika" loaded with illegally mined river bed materials having registration number WB/85/2907 and (ii) 03 (three) numbers of shovels.

I, SI Bandhan Roy of Pradhan Nagar PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against the drivers and owners of the seized vehicles having registration number WB/85/2907 to the effect that today (23.08.2025) at 08.30 hrs, I received a specific source input regarding illegal mining activity being carried out at the Mahananda river bed near lalchad ghat, Milon More under Pradhan Nagar PS, Dist. Darjeeling. It was reported that river bed materials were being illegally excavated and loaded onto the vehicle for their illegal gain. Upon receipt of the information, I made a General Diary entry vide Pradhan Nagar PS GDE No. 1420 dated 23.08.2025 and informed you. As per your kind order and direction, I proceeded with a team in a Govt. vehicle to verify the veracity of the information.

On the way the source informed that the vehicle is loading illegally mined river bed materials at the Mahananda river bed near lalchad ghat, Milon More under Pradhan Nagar PS, Dist. Darjeeling and proceed towards Devidanga Bazar. At around 10:20 hrs on arrival at Kolabari, near Devidanga Bazar under Pradhan Nagar PS the said vehicle was spotted. Upon noticing the police presence, the drivers and owners attempted to flee but abandoned the vehicle Kolabari, near Devidanga Bazar and escaped on foot. Despite efforts, the drivers and owners could not be apprehended. Upon physical verification, the vehicle having registration number WB/85/2907 was found to be loaded with illegally mined river bed materials. Enquiries regarding the owners and drivers yielded no leads as both were found to be absconding. Accordingly a proper seizure was carried out viz: :(i) One blue colour tractor styled as "Sonalika" loaded with illegally mined river bed materials having registration number WB/85/2907 and (ii) 03 (three) numbers of shovels at the site in between 10.45 hrs to 11.00 hrs under video surveillance under section 106 BNSS.

Under the above circumstances, I pray before you that a case be registered under appropriate sections of law against the drivers and owners of the vehicle having registration number WB/85/2907 involved in illegal mining, and arrange for its investigation.
