Subject: FIR Against Husband and In-Laws for Domestic Violence, Dowry Demand, Threats and Harassment

Respected Sir,

I, Smt. Pompa Barman, daughter of Shri Prahlad Barman, resident of Tara Para, Assam More, Jalpaiguri, Kotwali P.S., Mohit Nagar P.O., District Jalpaiguri – 735101, hereby lodge this written complaint against my husband and his family for continuous domestic violence, dowry demands, physical assault, and mental harassment.

My husband Rana Roy, son of Shri Ratan Roy, resident of Bou Bazar, Salugara P.O. Bhaktinagar, District Jalpaiguri, Siliguri – 734003, married me around 8 years ago. Since the past 6 years, I have been subjected to regular physical assault, quarrels, beatings, harassment, and threats by my husband and his family members namely – Father: Ratan Roy, Mother: Ratna Roy, and Younger Sister: Priyanka Roy.

My husband is also addicted to Drugs and Alcohol and frequently demands money from me for his addictions. He has also sold all my gold jewellery without my consent. I have been forced and pressurised for dowry and money repeatedly by him and his family.

In the month of March 2025, after severe quarrelling and beating, I was forced to leave my matrimonial home and return to my parents' house in Jalpaiguri. Later, my husband came to take me back and in the presence of the Gram Panchayat and family members, he gave a written apology letter, assuring that such incidents would never occur again. However, despite that, he has once again continued his violent, abusive, and threatening behaviour towards me.

I am living in constant fear for my life and the safety of my minor son, aged 4 years.

Therefore, I request you to kindly register an FIR against my husband Rana Roy and his family members for offences and take strict action so that I may get justice, protection, financial settlement, and a peaceful life for myself and my child.
