PRIYANKA KUMARI SAH**, D/o Ram Kishor Sah, resident of South Shanti Nagar, Binay More Bazar Dabgram- II, South Shanti Nagar, G.P. Dabgram -II, Block Rajganj, District- Jalpaiguri before the Ex- Officio Marriage Registrar Sri Pulak Bhowmick before the Parties and witnesses by following all required formalities.

Sir, since last day i.e. 20.08.2025 the family members of my wife are continuously assaulting her and kept her in captivity and they are planning and pressurizing my wife to get married with someone else and when I received the information about such incident I rushed to the parental house of my wife and reaching there I found that her father and other family members are forcefully pressurizing my wife to get married someone else and when I requested them to not do such illegal acts they also assaulted me very badly and they further pressurizing my wife to divorce me at any cost.

Sir, I am in great fear that the above mentioned persons will kill my wife for their fake social prestige and they may commit Honour Killing.

Therefore, in such situation I am in great fear and taking the shelter of law, Kindly do needful as per law against the wrongdoers.
