Re.- Complaint regarding forgery/ falsification
I would like to submit as follows-

- That My Hindu Undivided Family Suresh Kumar Agarwal HUF, of which I am the Karta, is a shareholder of Suman Tea & Plywood Industries Private Limited, a private limited company having its Registered Office at 240B A J C Bose Road, Kolkata-700020.
- 2. That I have found after downloading the form MGT 7A filed by the said Company with the Ministry of Corporate Affairs for the year ended 31<sup>st</sup> March 2023 that I held in the name of my HUF 1950 Equity Shares as on 31<sup>st</sup> March 2023. The List of Shareholders as per the Form filed by the Company for the year 31<sup>st</sup> March 2023 is enclosed marked Annexure A.
- 3. That I have found after downloading the form MGT 7A filed by the said Company on 5<sup>th</sup> December 2024 with the Ministry of Corporate Affairs for the year ended 31<sup>st</sup> March 2024 that the said HUF does not hold any Equity Shares in the said Company as on 31<sup>st</sup> March 2024. The List of Shareholders as per the Form filed by the Company for the year 31<sup>st</sup> March 2024 is enclosed marked Annexure B. The Form MGT 7A also does not provide details of transfers made and date of transfer, although the same is required mandatorily, we came to know the said fact from MGT 7A on dt 23.7.25 when we got a certified copy of it from ROC, a copy of which is also enclosed herewith for your information.
- That I mention specifically that I have not signed any share transfer form or any instrument of transfer for the transfer of these shares to any person whatsoever.
- It is apparent that the said transfer of shares has been done fraudulently and by forging my signatures.
- That this illegal act of forgery in the form of shares transfer has been done by the Directors of the said company Sri Sandhir Agarwal, Sri Debashis Dey and Sri Shyamal Sarkar..

I would also like to mention that the MGT-7A Form was filed by the Company on 5<sup>th</sup> December 2024, after I had filed a petition alleging oppression and mismanagement in the said Company before the National Company Law Tribunal on 3<sup>rd</sup> December 2024 for which due notice with copy of petition was served on the Company and both above directors on 1<sup>st</sup> December 2024.

I also wish to mention that I had filed a FIR against the same persons Sri Sandhir Agarwal and Sri Debashis Dey in your Police Station being Bhaktinagar PS Case No. 535/24 dated 14<sup>th</sup> June 2024 u/s 465/468 of IPC regarding fraudulently terminating me as the Director of the Company on the basis of a resignation letter on which my signature was forged.

I shall request you to please take this complain of cheating and forgery and investigate the same so that I may get due justice.
