Respected Sir/Madam,

I, Smt. Alpana Sarkar (Paul), D/o- Sri Probhat Sarkar, W/o- Sri Sajal Paul, Housewife by Occupation, presently residing at my parental rented house at C/o- Sri Probhat Sarkar, Jyotinagar Colony, Ward No. 04 of S.M.C, P.O. Siliguri Bazar, P.S. Siliguri, Dist. Darjeeling, Pin No. 734005, would like to report you the following facts:-

- 1) That on 01/12/2018 my marriage was solemnized with my husband Sri Sajal Paul, Son of Sri Sudhir Paul and Smt. Asha Paul, Resident of Village & P.O. Gossairhat Bandar, P.S. Sitalkuchi, Dist. Coohbehar, Pin No. 736172, according to Hindu law, rites, customs at my parental house.

At the time of marriage my father gave cash Rs. 2,00,000/- (Rupees Two Lacks) only and different Gold ornaments and Furniture and beddings etc. and other household articles to my husband as dowry as per demand of my husband and his Family.

After my marriage I started to live with my husband in my in-laws house, residing jointly, but few days later my in-law namely (a) Sri Sudhir Paul, S/o- Late Hiralal Paul and (b) Smt. Asha Paul, W/o- Sri Sudhir Paul misbehaved with me without any reasonable ground. Thereafter after some days I saw that my husband was not maintaining a good relation with me as a husband and wife and he was continuously told me that he is not satisfied with dowry of our marriage. I ignored everything which was bad for our relationship.

- 2) That it is mentioned here that my husband is a well-established business man and he has various plots of land in several places. As such reason mostly every day I was in under surveillance of my husband and as and when as per his wish my husband has started mentally and physically tortured upon me and he has

manhandle me by keeping me in the dark room locking it from outside he even does not give me to eat food and very horribly beat me every night.

Even my husband doesn't provides any expenses for purchases necessary items to me for living being a married women. Being a husband he has no responsibility against me. My husband and in-law always listen to me that I am a beggar's child.

- 3) That Several times my husband drove me out from my room and locked the room but at the intervene of the in laws have come to interfere in our personal conjugal matter and have threatened me that if I don't listen to my husband they will throw me out of my house along with locality.

It is mentioned here that my in-laws provoked to my husband to increase the torture upon me and for more dowry from my parents.

- 4) That my husband told to me to give him all my gold ornaments for mortgage for his personal purpose and when I denied it, then my husband and my in-laws torture and used various filthy language upon me.
- 5) That in the month of August of 2019 when I was pregnant my in-law told me for abortion and when I denied propose of abortion, then they increase the torture upon me and they made the several dangerous situation for the abortion. Then I informed all about the matters to my parents and then my parents tried to bring me at parental home, but my in-laws are denied same. On the next day my mother in-law asks me to make tea, then I went to kitchen and lit the gas stove, my clothes caught fire. I quickly took water from the basin and splashed myself and the fire went out. Later I took a close look and realized that all the gas furnaces were opened and gas was coming out. My mother in-law Smt. Asha Paul stood behind and told me I survived for today, but I will not get this opportunity in the future.
- 6) That thereafter at the time of pregnancy day by day increase the torture upon me and finally for those reason 2 (two) times I was admitted at Hospital as per my physical conditions and the doctor suggest to me immediately admit in Hospital.
- 7) That finally I gave birth a girl child on 06/12/2019, out of our said wedlock relation and my husband and in-laws refused to took me at home only for the reason of I gave birth a girl child. Then I was forced to go to my father's house at Jyotinagar

Colony, Siliguri. After 3 (three) months on several request of my parents they agree to allow me to enter their house at Gossairhat Bandar. Even at the events of baby shower and rice ceremony of my child they did not allowed to my parents or relatives to participate at family occasion. When I objected to those bad behaviour then my mother-in-law kicks on my stomach.

- 8) That on 12/04/2022 in occasion of family ceremony at matrimonial home my husband slapped me on the cheek in front of every invited persons and family relatives without any reason. Thereafter same day at night my husband came at house as huge drunk condition and started to assault me by fists and blows and by kicks and he dragged me out of my father house by catching my hair log and started to abuse me in filthy and offensive language and told me that until and unless I do not bring cash Rs. 1,00,000/- (Rupees One Lack) only from my father's house he will not allow me to live in his house.
- 9) That in early of February, 2023 at winter night when I was sleeping my husband tried to kill me by pressing a pillow on my mouth, then I somehow managed to escape from our bed room with my minor daughter. Thereafter I spend every days doubting my and daughter's life and each and every night is really scary for me.
- 10) That finally on 18/02/2023 my husband drove out to me along with my minor daughter from my matrimonial home. Even they took all my money and remove all the gold ornaments from my body and took all my original documents i.e. Aadhaar Card, Ration Card & Voter Card and my daughter's original documents i.e. Birth Certificate, Aadhaar Card & Ration Card. Presently my husband continuously threatened to me and my others family members through phone by several phone numbers. Even my minor daughter could not admission in School due to original documents and at present she is 6 years old.
- 11) That for the above reasons I went to Sitalkuchi P.S, Dist. Coochbehar for lodge a written complaint, but the Sitalkuchi P.S authority refused to lodge my complaint. Then I had filed an application being Case No. P.L 1255/2023 to S.D.L.S.C, Mathabhanga, Dist. Coochbehar for family counselling. Lastly on 24/01/2024 final counselling was failed and the A.D.J-cum- Chairman of S.D.L.S.C, Mathabhanga, Dist. Coochbehar gave liberty to me to file a case in recourse of law.

Presently I am suffering from mental depression and disappear of human activity for this various reasons. Now I am living at my parental home with my

minor child and after those incidents my aged father is seriously ill and who already suffering from several diseases.

I, therefore request you to kindly take necessary legal action against the aforesaid persons namely 1) Sri Sajal Paul (Husband), 2) Smt. Asha Paul (Mother-in-law) and 3) Sri Sudhir Paul (Father-in-law) for their commission of the aforesaid offences.
