Complainant – Payel Haldar (Saha), W/o Indrojit Haldar, resident of Natunpara Rasbihari Sarani by lane, P.O – Rabindra Sarani, P.S – Siliguri, Dt – Darjeeling.

Accused – 1) Indrojit Haldar, S/o Pinak Haldar 2) Swapna Haldar, W/o Pinak Haldar all are resident of Atul Prasad Sarani by lane, Hakimpura, Ward No: 15, Near Hello Kids Purba Vivekananda Pally, P.O + P.S – Siliguri, Dt – Darjeeling.

Madam,

With due respect I the above named complainant wants to state you that -

1. That on 8/8/2024 I got married with the accused No: 1 in Siliguri and after the marriage the accused haven't took me to their home instead of that the accused kept me in hotel. The accused left me there intentionally and went away in their home. On 15/8/2024 I was then taken to my matrimonial house. The accused No: 2 has made this plan in order to create pressure upon the family members of the complainant so that they were forced to give dowry in cash.
2. That after I was taken to my matrimonial house all my sridhan property was being taken away by the accused. In my marriage I got some gifts and money approximately 5000/- to 6000/- from the invited people but all those things were kept in possession of the accused. When I further asked to provide me those sridhan property, the accused literally threatened me not to claim those as it all belongs to them if I claim I will be tortured both physically and mentally.
3. That after few days of my marriage the accused started torturing upon me both mentally and physically. The main reason is my son Prince Ranjan Roy. Prince Ranjan Roy is my son of my First husband. Now I have obtain divorce from my first husband but upon divorce the Ld. Court has order son can come to me and stay with me at any point of time. Accordingly when I requested the accused to keep my son for some days, thereafter the attitude of the accused changed. Although before the marriage every fact

was told to then and they completely agreed upon that issue but now after the marriage the situation completely changed.

4. That after few days of marriage I came to know that the accused No: 1 does not do any kinds of work but during the time of marriage it was being told to us by the accused that my son earns 1,00,000/- rupees per month from his business. Instead of work the accused No: 1 always see to be in intoxication condition. All time throughout the day and night the accused No: 1 is in some intoxication position. Whenever I try to go near him I am afraid that at any point to time the will be a risk of my life.
5. That several time I tried to stop the accused No: 1 but on that condition, I was being beaten mercilessly by the accused No: 1 and accused No: 2 helps the accused No: 1 by bringing several items such as wooden stick through which I was being bitten in everywhere in my body. I was not being allowed to call my parents as my phone was being taken away and no food was being given to me. I was not permitted to go for any treatment and all and ever household work is being done by me without any maid in such painful situation.
6. That my father-in-law Pinak Halder used to watch every thing but never ever protest the accused. On 26/9/2024 at about 2:30 am at night I was thrown away from my matrimonial house I was bitten that day very heavily and I was in pain. I also got fainted and some blood was coming from my nose. As the accused hey me with kicks and blows together with wooden stick. The accused No: 1 as usual were intoxication position.
7. That now I am very helpless situation. The accused do not send me any money for my maintenance. The accused threats me over phone late at night and threats that they will kill me. I am in a very distress position and I come before you seeking for justice. I request you to investigate the matter and arrest the accused person immediately and to start a specific case against them upon which I will be helpful and thankful to you.
