**Subject: Complaint for Commission of Further Non-Bailable Offences Threats
Extortion and Unlawful Demand of Money - in continuation of Matigara P.S.
Case No. 492/2025**

Sir,

1, Mr. Tenzing Lodoe Bhutia, S/o Late Lobsang Jinpa Bhutia, resident of 43/A, Gundri Bazar,
Ward No. 12, Kurseong, P.O. & P.S. Kurseong, Dist. Darjeeling, most respectfully state as
follows:

1. That I am the complainant in Matigara P.S. Case No. 492/2025 registered on my complaint dated 29/07/2025 regarding illegal trespass, destruction of boundary wall and temporary hut, and threats to life and property by the accused persons namely (1) Sunilal Oraon, (2) Vhodo Oraon both sons of Late Bhedia Oraon, (3) Sebni Oraon, W/o Vhodo Oraon, (4) Puspa Oraon, W/o of Sunilal Oraon, (5) Rita Oraon, W/o Podra Oraon, (6) Jhepa Oraon, W/o Kastu Oraon, and their accomplices.
2. That all accused persons were granted surrender bail on
04/08/2025 by the Ld. ACJM, Siliguri.
3. That immediately after their release on bail, the accused persons, emboldened by their liberty, have committed fresh and graver offences punishable under the Bharatiya Nyay Sanhita, including but not limited to:
 - a. Extortion by criminal intimidation threatening me and my co-owners with physical harm and demanding a large sum of money to "settle the matter" and to allow us to use our own land.
 - b. Criminal intimidation with threats to kill me, my family members, and labourers working at the site if we resume construction or report their acts to the police.
 - c. Unlawful assembly with dangerous weapons for the purpose of intimidating us and obstructing our possession.
 - d. On 24/08/2025 when I visited the said land I found that the accused person wife constructing a bamboo boundary above our boundary wall which was already constructed before and when we stopped them they started using filthy languages and started assaulting us.

DECLARATION REPORT

4. That on multiple occasions between 05/08/2025 and 10/08/2025, the accused persons, accompanied by several unknown associates, have approached me and my labourers at or near the land in Noulja Baragharla (schedule described in the earlier FIR) and issued direct threats to life while making unlawful demands for money.

5. That these acts are fresh incidents constituting separate cognizable offences, independent of and in addition to those in Case No. 492/2025. These are non-bailable offences attracting sections of the Bharatiya Nyay Sanhita such as, Attempt to commit culpable homicide, Extortion, Extortion by threat of death or grievous hurt, Criminal intimidation, Criminal trespass after preparation for hurt/intimidation:

6. That I have reason to believe the accused persons will cause serious harm to my life and property if immediate preventive and penal action is not taken.

I therefore request your good office to, kindly treat this as a fresh complaint and register a separate FIR for the above-stated incidents

under appropriate non-bailable sections of the Bharatiya Nyay Sanhita, and/or add the relevant additional sections to the ongoing Case No. 492/2025, and take urgent steps to arrest the accused persons and ensure my safety and that of my family and labourers.
