do hereby submit this Complaint to
the following facts:-

That my above named husband namely Suchil
Gupta is a railway employee under Indian
Railway and now posted at New Jalpaiguri
Station.

That today i.e. 22.08.2025 at about 6.40
P.M. my husband and his friend namely Mahesh
Bhushan waiting at South Chandra Nagar, Binoy
More Bazar, Pipe Line Road near Paswan Rice
Shop to visit their Advocate namely Suchil Paswan
at that time some unknown person (10-15
person) suddenly attacked on my husband
and they had use punch, hockey stick
knife, belt, Bljiali and what ever they have
found their hand brutally. They used abusive
and Slagging languages.

3/ That resulting my husband got Serious
injured. He received head injury, Chest
injury and his face has covered by
blood. Thereafter getting knowledge about
the said incident myself and my relatives.

4) That they also threatened that they will sure kill my husband without any reason. In the mean time they also snatched one gold ring, one gold chain and Cash Rupees 10,000/- All the above stated incident has been captured in CCTV Camera at Spot.

5) That from the local peop I came to know that those miscreants namely 1) Ranjan Sah s/o - Loton Sah, 2) Rahul Sah, 3) Loton Sah, 4) Munna Sah s/o. Loton Sah, 5) Rabi Sah s/o - Loton Sah, 6) Loton Sah s/o - not known - all are of Malgaon, Pokrajote Tea Auction Road. 6) Nitesh Sharma of Dangeipara 7) Mrd. Salman Khan of Alupatti, Hillcart Road 8) Chandan Singh of Tea Auction Road, green park, Pradhanagar and many more (name unknown).

7) That now I am suffering from mental trauma and so much afraid after the above incident now I passing my time in very hard condition.

For the above Circumstances, I request your goodself to take all necessary legal action against the above named persons and punish them as per law.
