Bhaktinagar, District- Jalpaiguri and after entering inside the house in found that one Kirloskar Water Pump and other things have been stolen away by cutting the pipes by some unknown miscreants.

Sir, it is also to be mentioned here that on 25.07.2025 at about 08:00 AM, also theft was committed in my above mentioned under construction house many of the Bathroom fittings like 3 Nos. Push Valves, 6 Nos. steel Taps, Cistern Box, Commode Accessories, Bash Copling Concealed Valve and other things have been stolen away by cutting the pipes by some unknown miscreants and the same incident was informed to the Police and one Patrolling Van also visited the above mentioned house but no action was taken.

Sir, it is to be mentioned here that theft has become regular menace in our locality and the miscreants are doing such act on regular basis and they have no fear of law, and the residents of the locality are spending there life in great fear.
