Subject: Urgent Prayer for Registration of FIR against **Mintu Sarkar @ Akash Sarkar and Mithun Sarkar** for Cruelty, Criminal Intimidation, Circulation of Obscene Material, and Character Assassination of a Woman

Respected Sir,

1. **That I, Maya Mehta, daughter of Shri Arun Mandal,** am the complainant in the present case, presently residing at ISKON Mandir Road, near Pepsi Godown, Paradise Building, P.S. Bhaktinagar, District Jalpaiguri, Pin – 734001, and having my permanent address at Section-AS, Sadarpur Colony, near Indian Public School, District Bareilly, P.S. Sector-45, Noida, Uttar Pradesh, Pin – 201301.

2. **That I was lawfully married to the accused No. 1, namely, Mintu Sarkar @ Akash Sarkar, son of Bablu Sarkar, on 12th March 2023, as per Special Marriage Act, and the said marriage is evidenced by Marriage Certificate No. WB32801002060202892-2023-22266, issued by the Registrar General of Marriages, Government of West Bengal. The said certificate bears the photograph, names, and signatures of the parties and witnesses and is annexed herewith.**
3. **That after the solemnisation of marriage, I began residing with my husband at the matrimonial home situated at Pipeline Road, Madhya Shantinagar, Dabgram, P.S. Bhaktinagar, District Jalpaiguri, Pin - 734004, but very soon thereafter, the accused started subjecting me to grave mental, physical, and emotional cruelty. He used to abuse me verbally, assault me physically, and humiliate me in front of others on trivial issues.**
4. **That the accused Mintu Sarkar @ Akash Sarkar, mobile number 7679096683, also continuously pressurised me to hand over money to him. I was working at Alishan Bagicha Bar, Sevoke Road, Siliguri, and the accused regularly demanded a portion of my earnings and misappropriated my financial resources.**
5. **That the mother of the accused No. 1 also corroborated and encouraged the acts of cruelty, and prevented me from leaving the house despite my repeated requests. I was treated as a subordinate without dignity and subjected to harassment on a daily basis.**
6. **That after approximately one year of such unbearable torture, I finally managed to leave my matrimonial home about six months ago. However, since then the accused has not allowed me to live in peace and has engaged in a campaign of blackmail, defamation, and intimidation.**
7. **That the accused Mintu Sarkar @ Akash Sarkar created fake social media accounts and published my private and intimate photographs and videos on Instagram and Facebook with the sole intention of assassinating my character and reputation. Specific links evidencing this cyber crime are:**

8. **That the accused has been constantly threatening me with dire consequences, including death threats, and using the most filthy and derogatory words against me such as "Randi" and "MC", as is evident from multiple WhatsApp chats and screenshots annexed herewith. These messages constitute not only abuse but criminal intimidation and obscenity.**

9. **That in all these heinous activities, one Mithun Sarkar, son of Ranjan Sarkar, resident of Haiderpara, Araf Tower, in front of Apollo Pharmacy, 3rd Floor, District Jalpaiguri, mobile number 8981719575, has been actively colluding with accused No. 1. He has assisted him in creating fake accounts, editing and circulating obscene materials, and spreading defamatory content about me.**

10. **That the deliberate acts of both accused are intended to outrage my modesty, assassinate my dignity, and defame me in society, and they have caused me immense mental agony, humiliation, and trauma. My safety and reputation are in grave danger due to their continuous threats and criminal behaviour.**

11. **That by their above conduct, the accused persons have committed cognizable offences punishable under Sections 85, 316, 75, 77, 78, 79, 351, 356, AND 61 of the BNS and Sections 66C, 66D, 66E, 67, and 67A of the Information Technology Act, 2000.**

12. **That I am enclosing the following documents and evidences along with this complaint for your reference and immediate action:**

- Certified copy of Marriage Certificate dated 12.03.2023.
- Aadhaar card of accused No. 1, Mintu Sarkar @ Akash Sarkar.
- Screenshots of WhatsApp chats containing abusive language and threats.

13. **That I therefore pray before your good office to kindly register an FIR against accused No. 1, Mintu Sarkar @ Akash Sarkar, and accused No. 2, Mithun Sarkar,** under the aforesaid provisions of law, seize their mobile phones and other electronic devices, remove the obscene materials from social media, and provide me necessary protection to ensure my life, liberty, and dignity are safeguarded.
