I am writing to formally report
a burglary that occurred in my shop
on 25/8/2025 at approximately 11:45 AM.
A group of unidentified persons entered
my shop to buy jewellery, and looted
a substantial quantity of jewellery
weighing around 100 grams. They fled
the scene immediately and was
untraceable. The shop's CCTV cameras
captured footage of the suspects.

The incident has caused huge
financial loss and distress to me.
I request your immediate attention
