Naxalbari, Dist. Darjeeling, on 21/09/2016 under the Special Marriage Act, 1954, and said marriage has been registered at the Office of Sri Suraj Lepcha, the Addl. Dist. Sub-Registrar & Ex-Officio Marriage Registrar, Bagdogra, Dist. Darjeeling (W.B).

After the said marriage I started residing with my husband at my paternal house as husband and wife at Stalin Nagar, Upper Bagdogra, P.O. & P. S. Bagdogra, Dist. Darjeeling. PIN 734014, West Bengal, as our marriage was a love marriage and since our marriage has not been accepted by the family marriage the demands of my husband has been fulfilled by my sister as per her capacity. At the time of marriage they demanded one Mahindra Thar SUV, One Apple I-PAD, One Apple watch, one Samsung has been agreed by my husband that the aforesaid articles shall be given to him after the marriage as per during his matrimonial accord.

My husband is at present working in Agam Singh Giri Primary School at Tarabari as a permanent teaching staff.

Thereafter, my husband used to stay with me at my paternal house as our family member. My family members have huge respect for him.

I also came to know that my husband is a habitual drunker. He used to drink almost every night and always inflicted torture upon me both physically and mentally in presence of my elder sister and other family members and relatives and I have to digest all such humiliations and tortures upon me in him will ruin our life but my all attempts went in vain.

I also visited my matrimonial home at times at Panighata Bazar, P.O. Panighata, P.S. Naxalbari, Dist. Darjeeling, where also I was subjected to torture by my husband both physically and mentally in presence of his parents. I was not accepted at my matrimonial home as a member of the family by my inlaws. And during my stay at my matrimonial home I was never provided with the daily square meais you are belong to lower caste". My husband also, now and then, used to inflict torture upon me, both physically and mentally, in intoxicated & drunken condition and on any protest being raised against him; he always used to assault me mercilessly.

After spending some time in my matrimonial home, I came to know that my husband has an illicit relationship with a lady since long before my marriage and that lady has been residing with my husband as his kept wife in her own house. It is to be mentioned here that I am the only legally married wife of my husband and the marriage between us is still subsisting.

I have been immensely tortured by my husband and I was never given the status of a legally marry the said lady without any obstruction from my side.

Today i.e. on 22/08/2025 at about 7.20 PM my husband alongwith my husband visited at my house at Bagdogra and abused me in filthy and offensive language and also assaulted me and my elder sister inhumanly and forcefully stolen away all the gold ornaments and cash of Rs. 1,30,000/- from my dire consequences if I do take any legal step against them or inform the matter to any authority. Thereafter, they fled away from the spot.

Said lady had also threatened me with dire consequences if I do not Divorce my husband immediately. She also threatened me to kill me if I ever meet with my husband and will also implicate me in a false case.

I, therefore request you to please take immediate legal action against the above named culprits namely 1) Tribhuwan Rai, (M- 79086-93133/96140-12206) & 2) the lady above noted as per the provisions of law considering the circumstances stated in above.
