Respected Sir,

With utmost respect, I ASI (UB) 598 Sibū Das do hereby lodge a written complaint against one who identified himself, Nandalal Kamti s/o Bimal Kamti, of Village - Rajendranagar, Junction, Coolpara (Mobile-8972901959). The fact of the incident in brief is that today on 26.08.2025 at about 13:00 hours while I, was performing M/C mobile duty near Anandalok Hospital more one Nandalal Kamti s/o Bimal Kamti who was playing a rickshaw van suddenly come in middle of the road on the wrong side. The on duty CV-620 Baren Adhikari tried to clear the traffic and asked him to go by the right side, that person suddenly become furious and started hot altercation with CV 620 Baren Adhikari and abused him with filthy languages and threatened him with fatal consequences. At that time when I went there and asked him to clean the way he stood in the middle of the road created huge traffic jam. That person namely Nandalal Kamti s/o Bimal Kamti had violated my lawful instruction and had obstructed in performing Govt. duties. He harassed CV-620 Baren Adhikari while he was doing the traffic regulation duty.

Despite repeated instruction the accused person refused to follow traffic rule or the order of the on duty police personals.

Therefore, I request that necessary legal action may kindly be taken against the accused person as per law.
