With utmost respect, I ASI (UB) 598 Sibu Das do hereby lodge a written complaint against one who identified himself, Nandalal Kamti s/o Bimal Kamti, of Village – Rajendranagar, Junction, Coolipara (Mobile-8972901959). The fact of the incident in brief is that today on 26.08.2025 at about 13:00 hours while I, was performing M/C mobile duty near Anandalok Hospital more one Nandalal Kamti s/o Bimal Kamti who was playing a rickshaw van suddenly come in middle of the road on the wrong side.
