Sir,

I, Neha Agarwal, Wife of Late Pratik Agarwal (deceased on 19/08/2025) wanted to lodge a formal complain in your PS, the details of which are as follows:

1. I, Neha Agarwal along with my now deceased husband, Pratik Agarwal and my son namely Jhanish Agarwal were residing in our residence at Green Vista Apartment at Bhanunagar main road, Ward No. 43.
2. My now deceased husband, Pratik Agarwal was carrying on the business of Medical Shop namely "All is Well" at PBR Tower, Sevoke road, Check Post.
3. I was shocked and devastated to learn that my now deceased husband, Pratik Agarwal, had apparently committed suicide by shooting himself dead with an improvised pistol on 19.08.2025 at about 12.30 pm in our residence. However, I have strong reasons to believe that my husband committed suicide under undue mental stress or incitement which left him with no other option but to take the fatal step.
4. It is my strong believe that he was under a situation of unbearable harassment or torture, leading my husband to see suicide as the only escape.
5. I also believe that he was subjected to extortion and blackmailing by unknown miscreants and was under immense mental stress leading to this drastic step.

I, earnestly urge you to lodge a criminal case under relevant Sections of the Bharatiya Nyaya Sanhita and other relevant Sections whichever is applicable

I seek a fair investigation so that my deceased husband gets his due justice and the culprits are punished for their crimes. Your appropriate and timely action is highly solicited.
