Sir,

In producing herewith one arrested person namely Rafikul Sk (27 years) S/O Lt Bishu Sk of Muncher para, Choto Sujapur, PS Kaliachak, Malda along with the following seized articles under seizure as per seizure list:

- 1) One black colour back pack style as Quechua containing 1 kg 987 grams of brown sugar i.e. 1.987 kgs which was packed in a transparent plastic.
- 2) One mobile phone style as OPPO Reno 6 5g, having IMEI no 86592405783476/68 and connecting sim 6294679551.
- 3) One silver wagonr car having registration no WB 02 AG 0152, engine no K10BN7383899

I, SI Youel Lepcha, S/O Jai Tshering Lepcha, of Bhaktinagar PS under Siliguri Police Commissionerate, hereby submit this written complaint against the above-mentioned accused person. On 26.08.2025, at about 13:50 hours, I received reliable information indicating that an individual traveling from the Ashigarh area in a silver Wagonr car with registration number WB02AG0152 was suspected of possessing a substantial quantity of narcotic substances. This information was recorded in the Bhaktinagar PS diary as GDE No. 1058/25 dated 26.08. 2025. Following this, I informed the matter in writing to the In-Charge of Bhaktinagar PS and the SPC. Upon receiving directives, at around 14:01 hours, I, along with SI Srimanta Chatterjee, ASI Dhurbo Mishra, ASI Dipak Karmakar, and Constable 374 Debraj Biswas, departed from the police station in a government-hired vehicle to verify the validity of the information. This refers to Bhaktinagar PS GDE no. 1060/25 dated 26.08.2025 and M.C.C No- 4140/25 dated 26.08.2025.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

On the way to Eastern bypass, as per the order of IC PS, I called k 38 ASI Mukul Basu, C/ 986 Rajib Sarkar, and C/1429 Rajesh Barman to accompany us to work out the information. At approximately 14:25, we arrived at the eastern bypass in front of DS Automobile. Where we accompanied by SI Binod Jha and SI Raj Bihari Saha of Special operation group Siliguri police commissionerate.

Once there, I convince the owners of DS Automobile and Bijay Hotel to join us, and they agreed to cooperate. Their details are as follows: 1) Sujit Prasad (38 years old), son of the late Chandraka Prasad, resides in Shrastinagar near ISKCON Mandir, Ward No. 41, PS Bhaktinagar, District Jalpaiguri. He is the owner of DS Automobile, located on the eastern bypass under Bhaktinagar PS 2) Bijay Chandra Das (40 years old), son of the late Chitaranjan Das, resides in Baikunthapally, Ward No. 41, PS Bhaktinagar, District Jalpaiguri. He is the owner of Bijay Hotel, situated on the eastern bypass road under Bhaktinagar PS.

After that, I informed them about the available information and requested, in writing, that they accompany us throughout the process of any search and seizure. They provided written approval to join the police during the raid, search, and seizure. Acting on a tip-off, we detained a silver Wagonr car with registration number WB02AG0152, which was being driven by one individual. We identified ourselves and shared the information we had, explaining that he would be searched in person. The driver then disclosed his name and address, as noted above.

He admitted that he was in possession of brown sugar, intending to supply it to his designated customers as needed. I then offered him the option to be searched in the presence of a Special Executive Magistrate or by a Gazetted Officer. He agreed to be searched by one of them. Subsequently, I issued a notice in accordance with legal provisions regarding the matter.

I sent a written requisition to Shri Amit Adhikary, Inspector In-Charge of Bhaktinagar Police Station, requesting him to come to the eastern bypass in front of DS Automobile under the jurisdiction of Bhaktinagar PS to supervise a search and seizure operation. At 15:55 hours, Shri Amit Adhikary arrived at the location as the Gazetted Police Officer. Subsequently, under his supervision and in the presence of witnesses, Upon conducting a thorough search of the detained individual and his vehicle, I found the mentioned article i.e. black colour back pack prominently placed on the front seat.

Further being demanded in presence of Shri Amit Adhikary Inspector In-Charge, Gazette Police Officer the detained person failed to produce any valid document in support of aforesaid recovered brown sugar.

I seized the above noted articles at the spot under proper seizure list duly signed by the independent witnesses, I also labeled and sealed the same, the entire search and seizure was conducted under the supervision of Shri Amit Adhikary, Inspector In-Charge of Bhaktinagar PS. The whole process of search & seizure has been captured in audio & VDO graphed. The whole process of seizure was made on 26.08.2025 in between 16.05hrs to 16.55hrs

Being further asked, the apprehend person admitted in presence of Shri Amit Adhikary, Inspector In-Charge of Bhaktinagar PS and other witnesses that he procured the brown sugar clandestinely from elsewhere for the purpose of selling the same in high rate to his designed customer for personal gain by illegal means also disclosed that he has been dealing in such business of procuring and selling of brown sugar illegally for last few months.

Then, I arrested the above noted accused person namely Rafikul Sk (27 years) S/O Lt Bishu Sk of Muncheher para, Choto Sujapur, PS Kaliachak, Malda after observing all formalities and informing the ground of their arrest and issued necessary Memo of Arrest u/s 35 of BNSS.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely Rafikul Sk (27 years) S/O Lt Bishu Sk of Muncheher para, Choto Sujapur, PS Kaliachak, Malda and arrange for its investigation.
