I, Smt. Rupmita Das, wife of Sri Soumya Chatterjee and daughter of Sri Ratan Das, resident of Sreema Sarani, W/No.37 SMC, P.O. Rabindra Sarani, P.S. Bhaktinagar, Dist. Jalpaiguri, Pin: 734006 (W.B.), would wish to lodge this complaint against:

1. SRI SOUMYA CHATTERJEE, Son of Late Samir Chatterjee, permanent resident of Ramkrishna Sarani, Ranidanga, Village Bairatal, P.O. Kadamtala, P.S. Matigara, Dist. Darjeeling, Pin: 734006 (W.B.) and presently working at SITA OFFICE, 14th Floor, Tower-C, Building 7, DLF Cyber City, Gurugram, Haryana;
2. SMT. HAIMANTIKA CHATTERJEE, Wife of Late Samir Chatterjee, permanent resident of Ramkrishna Sarani, Ranidanga, Village Bairatal, P.O. Kadamtala, P.S. Matigara, Dist. Darjeeling, Pin: 734006 (W.B.) ~~and presently working at SITA OFFICE, 14th Floor, Tower-C, Building 7, DLF Cyber City, Gurugram, Haryana~~

I got married to Sri Soumya Chatterjee on 02nd August 2024 in presence of our parents and the marriage was registered. Before marriage, Soumya Chatterjee demanded a gold bracelet from my father which was given to him being valued at Rs.1,00,000/- (Rupees one lakh only). After the registration of marriage, Soumya Chatterjee, for some unknown reason, did not want to reside with me or to socially marry me and to take my responsibility and used to refuse my demands with utter neglect and did not intend to take me at my matrimonial home and all he used to ask money from me and my father and I confronted this issue several times with him, but he used to abuse me very badly and he even slapped on my face and threatened me to break the marriage if I try to stop him from asking money from my father.

I would like to further state that Soumya Chatterjee and his mother, Haimantika Chatterjee on several occasion used to threaten me and my family to obtain a divorce and on 02nd April 2025, they told me and my family to meet them at their rented home

at Shivmandir, P.S. Matigara, Siliguri and upon visiting, I found out several outsiders and local persons were present in that meeting and in that meeting, Soumya Chatterjee and his mother told me to take a divorce, to which I opposed and denied and my family was also not willing for divorce and eventually, our families entered into an argument and during that, Soumya Chatterjee, in front of his mother and my parents, slapped me again on my face, which was utterly disgraceful, disrespectful, shocking, cruel and inhuman and they threw me and my family out of their home.

That since 16th April 2025, Soumya Chatterjee, without informing me, has gone to New Delhi in the month of April 2025 where he is working at SITA OFFICE, at 14th Floor, Tower-C, Building 7, DLF Cyber City, Gurugram, Haryana and till date, he has not met me physically and last conversation happened between us on 08th May 2025 and when I requested him to come back and to get socially married, he refused to marry me and used very filthy words against me, my family and my character and his mother also, on several occasion, abused me and my parents very badly with filthy language and threatened me that her son (Soumya Chatterjee) will not marry me and I would not know his whereabouts and it is very much surprising, alarming and shocking that after marrying me, my husband, Soumya Chatterjee with the active aid, support and influence of his mother, Haimantika Chatterjee, has left me on my fate and now I am in a very much helpless state residing at my parental home.
